The record is taken up for hearing of the interim application filed by the petitioner praying for interim maintenance of Rs. 25,000/- per month for herself from the OP/husband

The petitioner's case in brief is that she was married to the O/P Babul Islam on 23.12.2020 as per Muslim rites and customs. At the time of marriage the petitioner's relatives gave valuable articles and gold ornaments as dowry as per demand of the OP. Since after the petitioner started living her conjugal life with the O/P. The petitioner alleged that during her stay at the in-laws' house the OP used to inflict physical and mental torture upon the petitioner on further demand of dowry. It is also alleged that the OP used to neglect to maintain the petitioner. At last on 18.02.2021 petitioner was driven out of her matrimonial house after being physically abused. Since then the petitioner has been residing at her father's house. The petitioner contended that during this period the O/P never provided a farthing towards her maintenance. The OP is an able bodied person. He is the Child Development Project Officer, Balurghat, South Dinajpur with a salary of more than Rs.1,00,000/- including other sources of income, with cumulative income of more than Rs 1,20,000/- per month. She prayed for interim maintenance of Rs 25,000/- per month for herself at this stage.

I have heard the Ld. Adv for the petitioner in the open Court

The Ld. Advocate for the OP vehemently contended, denied and disputes all the allegations raised by the petitioner and stated that the petitioner used to quarrel on trivialities. She did not want to lead a happy conjugal life with the OP. He also stated that she has left him voluntarily taking all her *stridhan* articles. The OP also stated that before the petitioner left their house, she used to frequently visit her paternal home without any prior notice. The OP further contended that the petitioner had filed the instant case only to squeeze money from the OP with ulterior motive. The OP stated that he is a Government employee of Child Development Office, Balurghat under South Dinajpur District and disclosed his monthly income as Rs. 42,650/- per month in his affidavit and declaration of assets and liabilities. The OP prayed for rejection of the instant prayer.

I have also gone through declaration of assets and liabilities by the respective parties

This is an interim stage. At this juncture this Court has to rely on the materials available to it in hand as the matter relates to socio-economic legislation. Though it is a fact that such

Babul Islam



cogent document has been produced by the petitioner, thus Court has to find a middle way to satiate the petitioner's grievance at this very interim stage. It be mentioned here that the O/P not yet challenged the factum of marriage. I must also add here that in every such cases the Court is also to strike a balance between the claim of the petitioner and the socio-economic condition of the OP as well. It will be mentioned her that in support of his contention the OP has filed copies of bunch of documents, but at this stage this court has limited scope to bank upon those documents because that can only be proved by having cogent, reliable and substantive evidence.

Considering the above facts and circumstances I think that I am not in a position to adjudicate the merits and demerits of the case. This will be looked into at the time of evidence. The Ld. Apex Court while explaining the object of the instant legislation stated - Section 125 is enacted for social justice and specifically to protect women and children as also old and infirm poor parents within the constitutional sweep of Art. 15(3) reinforced by Art. 39 of the Constitution. The provision gives effect to the natural and fundamental duty of a man to maintain his wife, children and parents so long they are unable to maintain themselves - *Savitaben v State* (2005)3 SCC 636 AIR 2005 CS 1809 2005 Cr LJ 2141

Considering the socio economic conditions of the parties and the affidavits of asset and liabilities of both the parties, I think the monthly income of the OP, should not be less than Rs. 40,000/- to Rs.50,000/- per month

Hence it is

ORDERED

that the petition u/s 125 CrPC filed by the petitioner Sahina Sultana dated 19.04.2022 praying for interim maintenance is hereby considered and allowed in part on contest. Petitioner is entitled to get interim maintenance of Rs.15,000/- per month for herself from the O.P.

Thus, the O.P. is directed to pay Rs.15,000/- per month for the interim maintenance of the petitioner. The O.P. is directed to pay Rs 15,000/- per month to the petitioner within 10 days of each succeeding month for which it becomes payable and dues

The order is effected from the date of filing the petition u/s 125 of CrPC i.e. 19.04.2022






