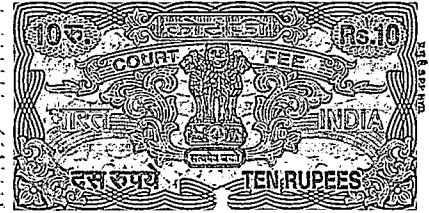
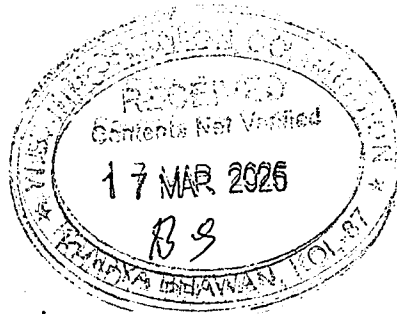

10. Grounds for 2<sup>nd</sup> appeal and the relief sought: Grounds of Appeal :  
i) FOR THAT the State Public Information Officer has been maintaining deceptive silence in regard to disclosing information without assigning any reason therefore.

- ii) FOR THAT the appellant requires to get supplied the photocopy of my answer sheet, question booklet and model answer and detail marks/scores obtained by me in the said examination, 2015, but such information has been refused to disclose by the State Public Information Officer, by maintaining deceptive silence on their part in spite of having such information.
- iii) FOR THAT the appellant requires to get supplied the information regarding lowest scores and/or marks obtained by the person who secured the appointment in my subject and/or aforementioned category, but such information has been refused to disclose by the State Public Information Officer, by maintaining deceptive silence on their part in spite of having such information.
- iv) FOR THAT the appellant requires to get supplied the information regarding the list of empanelled and waiting list candidates list with all details in respect of my subject and category, but such information has been refused to disclose by the State Public Information Officer, by maintaining deceptive silence on their part in spite of having such information.
- v) FOR THAT the appellant requires to get supplied the information regarding the last date of counselling and last date of appointment and/ or recommendation made by your good office for the aforesaid post in respect of my subject and category as specified above, but such information has been refused to disclose by the

State Public Information Officer, by maintaining deceptive silence on their part in spite of having such information.

- vi) FOR THAT the appellant requires to get supplied the information regarding number of post lying vacant for the post of Assistant Teachers of upper primary (2015) in different schools of West Bengal for recruitment in respect of examination of 2015 but such information has been refused to disclose by the State Public Information Officer, by maintaining deceptive silence on their part in spite of having such information.
- 
- vii) FOR THAT the appellant requires to get supplied the information regarding how many candidates have been recruited for filling of the vacancy of Assistant Teachers in respect of upper primary ( upper primary ) of examination 2015 as per the record of Commission till date but such information has been refused to disclose by the State Public Information Officer, by maintaining deceptive silence on their part in spite of having such information.
- viii) FOR THAT there is no ground available to the concerned Public Information Officer to refuse to supply information to the appellant under the Right to Information Act, 2005.
- ix) FOR THAT the information sought for by the applicant in his application dated 16-01-25 is not barred under Section 8 or 9 of the Act.

11. If 2<sup>nd</sup> appeal is filed after 90 days from the date on which the decision of the 1<sup>st</sup> Appellate Authority was received or after 135 days from the date of filing of the 1<sup>st</sup> appeal, explain the reason for the delay.
