No Candidate who is late by more than 1 minute shall be admitted to the examination hall.
2. No Candidate shall be allowed to leave the examination hall / room until half of the time of examination is over. No Candidate shall be permitted to go to the toilet during the last 15 minutes of the examination.
3. The Candidate shall be required to find out and occupy the seat allotted to him / her at least 15 minutes before the commencement of the examination.
4. No Candidate shall be allowed to leave his / her seat in the examination hall / room until the examination is over without permission of the Invigilator.
