Sir,

With reference to the above noted subject, I am directed to inform you that the SPIO of the West Bengal Board of Primary Education (WBBPE) has already replied in respect to the R.T.I application dated 21.08.2024 of the appellant, vide Memo No. 145/WBBPE/RTI/2025/46R-11/23, dated 14.01.2025 (copy enclosed).

Be it pertinent to mention here that in respect to query no. 1 of the appellant, I am further directed to inform you that the Board, on September 14, 2016 had issued a notice bearing Memo. No. 2150/BPE/2016 : 166L/TET/2014 to all concerned notifying the publication of the result of TET, 2014 as well as the resolution of the Board dated November 17, 2015 whereby the R.T.I. applications in regard to the marks obtained and supply of photocopy of OMR/Digitized Data Sheet regarding the TET, 2014 were invited for a period of 30 (thirty) working days from the date of publication of the results i.e. on and from September 15, 2016 to November 09, 2016 with a rider that no application beyond the said time would be entertained.

As the appellant did not respond to the said notice within the time limit he is not entitled to get the copy of OMR sheet of TET 2014. The aforesaid notice of the Board has been accepted by the Hon'ble High Court, Calcutta in W.P.A. No. 6269 of 2024 [Arafat Sardar & Ors. Vs. The State of West Bengal & Ors.] and W.P.A. No. 2503 of 2024 [Shiba Prasad Kar & Ors. Vs. The State of West Bengal & Ors.] and observed that the petitioner's failure to respond to the said notification of the Board disentitles them to get the relief as prayed for.
