In the extension of approval of Director of Madrasah Education (162/ME/13 dated 30.12.2015) direction was given to the District Officer Birbhum to select S.S in charge from the approve S.S as per guideline of Madrasah Shiksha Karmasuchi. He has fulfilled all the criteria, so prayed to approve him as MSS (HM) by inserting his name in the M.SC degree and D.EI.ED degree. It is to be mentioned that there is no need to give separate exam to add M.Sc degree in the Madrasah Service Commission for Hons. Graduate teacher.

- 2. Md. Akhtar Hossain, vide his application dated- 30.12.2020 requested for the following information from SPIO, Directorate of Madrasah Education:
 - i) Information of my application dated on 15.10.2019
 - ii) Supporting documents of the approval of Mojibor Rahaman, S.S. of Barsor Halima Khatun Madrasah Shiksha Kendra, District Birbhum.
 - iii) First inspection report made by the D.L.I.T, Birbhum, made in the year 2008.
- Grounds for 2nd appeal is non-receipt of information.

Deliberations and Decision:

- 4. The appellant is present virtually. The SPIO is absent.
- 5. First Appellate Authority is present virtually. He offered to reply to the appellant within a week.
- 6. However, going through the queries of the RTI application it is seen that the appellant is seeking personal information. It is exempted under S. 8 (1)(j), RTI Act. Therefore, the case is closed.
- 7. The matter is disposed of.
