WRITTEN SUBMISSION

1. That the present written submission is being filed by the appellant in connection with the hearing of the above-mentioned appeals before the Hon'ble West Bengal Information Commission.

2. That the appellant most respectfully submits that the Notice for Hearing issued by the Hon'ble Commission contains incorrect address particulars, namely wrong PIN Code and incorrect Post Office name of the appellant.

3. That due to such incorrect address details, the notice sent through the postal department was not capable of being duly served upon the appellant in the ordinary course of postal delivery.

4. That the appellant could receive a copy of the said notice only because of personal acquaintance with the local postal staff, and the notice was ultimately handed over personally by the postal peon.

5. That but for such personal intervention, the appellant would not have received the hearing notice at all, which could have resulted in serious prejudice to the appellant's right to be heard.

6. That service of notice at an incorrect address cannot be treated as valid or proper service in the eye of law and is contrary to the principles of natural justice.

7. That the appellant therefore humbly prays that the Hon'ble Commission may be pleased to take note of the said irregularity while adjudicating the present appeals.

With reference to the above noted Appeal Case No. 101610 of 2025, I respectfully submit the following explanation on behalf of the SPIO, Office of the BL&LRO, Tamluk-I, in connection with the reply furnished against the RTI petition vide Memo No. 1037 dated 28/10/2024.

In reply against **Query No. 1**, it is stated that **Khatian No. 221/1** recorded in favour of Smt. Nilima Das was created during the LR (Land Reforms) operation. Upon verification of the relevant records, it is found that the date of attestation in the concerned khatian is illegible in the available records. Due to such illegibility of the attestation date, the specific information as sought by the applicant could not be ascertained from the office records. Therefore, the query could not be answered precisely.

A copy of **Khatian No. 221/1 of Mouza Chandkhua, JL No. 285** is enclosed herewith for kind perusal.

In reply against **Query No. 2**, it is stated that **Khatian No. 161/1** recorded in favour of Sri Tanmoy Das is not found at present in the current record system. On verification, it appears that the entire area of the said khatian has already been transferred. The required information could not be retrieved from the existing digital records. Therefore, Query No. 2 could not be answered due to non-availability of retrievable data in the present system.

This is submitted for kind information and necessary consideration.

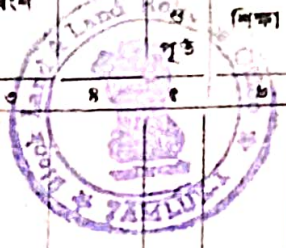

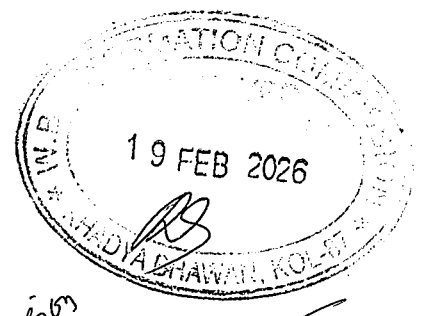

Respected Sir,

With utmost respect, I, Ratan Kr Kar, beg to submit that hearing in the above-mentioned docket numbers was conducted on 16/02/2026. I respectfully submit that I am highly dissatisfied as I have not received lawful, clear and consistent information from the office of BL&LRO, Tam-1 in connection with my RTI queries and the replies issued vide Memo No. 1037/24 and Memo No. 1038/24.

The matter relates to my own land records and the information sought is directly connected with my legal rights.

1. As per RS Record, the recorded owner is Ramendra Sundar Maity and no bargadar is recorded in the RS record.
2. Smt. Nilima Das became the lawful owner of the land by virtue of Registered Deed No. 2114 dated 12/03/1965. There is no mention of any bargadar in the said deed.
3. In 1985, BL&LRO, Tam-1 issued Homestead Patta from the land of Smt. Nilima Das in respect of Plot No. 494. If the land had been under any lawful bargadar, initiation of homestead patta from such land would not have been legally permissible. Therefore, by necessary legal implication, there was no bargadar recorded in 1985.
4. However, contradictory records are being reflected:
(a) RTI Memo No. 1038/24 indicates Nilima Das as owner without bargadar in 1985.
(b) KB Record of 1981 allegedly shows Ramendra as owner with bargadar.
(c) LR Record of 1989 reflects Ramendra as owner with bargadar in the same plot.
5. RTI Memo Nos. 1037/24 and 1038/24 do not provide a categorical and lawful clarification as to whether any bargadar was legally recorded in 1985 under the ownership of Smt. Nilima Das.

These conflicting positions clearly demonstrate that complete, specific and consistent information has not been supplied as required under the RTI Act, 2005.

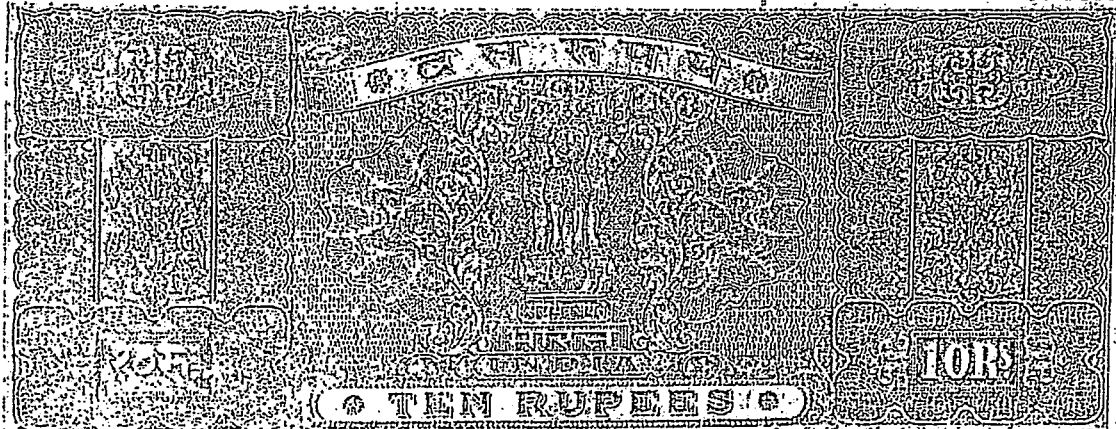

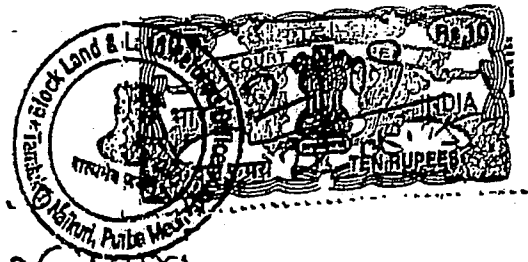

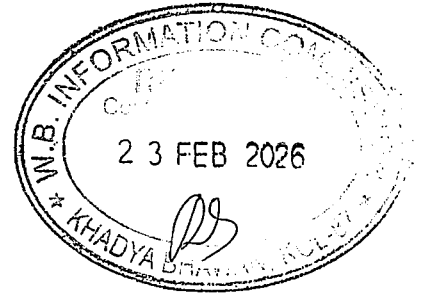

I, Ratan Kr. Kar, S/o Late Gour Ch. Kar,
Ward No. 19, Chandkhoya, P.S. Tamluk,
Dist - Purba Medinipur, Pin - 721628
most respectfully submit as follows:

1. That a hearing was conducted before the Hon'ble Commission on 16/02/2026 in connection with my RTI applications filed against Tamralipta Municipality.

2. That I filed RTI applications dated 03/04/2024 and 10/02/2025, but I have not received proper, specific and complete information as sought in my applications.

3. That the Public Information Officer (PIO), Tamralipta Municipality has provided vague, evasive and incomplete replies, which are not in accordance with Section 2(f) and Section 7 of the RTI Act, 2005.

4. Specifically:

(a) Regarding Building Permit No. SWS/OBPAS/1705/2023/290 dated 07/09/2023, I sought to know whether the said building plan is legal or illegal. Instead of giving a clear and record-based reply, the PIO gave a general explanation about the online scrutiny system.

(b) Regarding conversion certificate, the reply states that no conversion certificate has been issued to Mr. Ashini Kumar Sau, but no certified copies or supporting records were provided.

(c) Regarding site plan and hand sketch submission, proper documentary copies were not supplied.

5. That such incomplete replies defeat the object and purpose of the RTI Act and deprive me of my statutory right to obtain information from public records.

Therefore, I humbly pray that the Hon'ble Commission may kindly:

1. Direct the PIO to provide complete, clear and certified information as per my RTI applications dated 03/04/2024 and 10/02/2025.
2. Direct production of relevant records before the Commission.
3. Pass appropriate orders under Section 19(8) and Section 20 of the RTI Act, 2005.



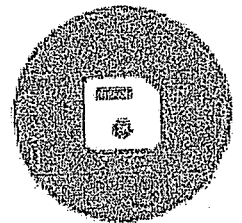

Facts on Record :

1. Shri Ratan Kr. Kar (hereinafter referred to as the appellant) submitted three second appeals before the commission against three RTI applications as noted above filed to the (i) SPIO, Tamralipta Municipality and (ii) SPIO, BL & LRO Tamluk-I, Purba Medinipur seeking some information :

- A) a) Appeal no. 100269/2026 date of RTI 03.04.2024 filed to the SPIO, Tamralipta Municipality for seeking the following information -
- i) Has Aswini Kr. Sau submitted any conversion certificate?
 - ii) Has Aswini Kr. Sau submitted any hand sketch of proposed site?
 - iii) Has the Municipality issued any site plan against proposed site?
 - iv) Can online building plan be sanctioned for 9 years old building?
 - v) Did an engineer visit the site to sanction the plan? If yes, please give me the date of visit and the name of engineer.
- B) a) Appeal no. 100022/2026 date of RTI 24.09.2024 filed to the SPIO, BL & LRO, Tamluk-I for seeking the following information -
- i) In 1985, Aswini Kr. Sau was given Patta from which land? Give the name of Rayat (Owner)
 - ii) If that Patta was given from the land of Nilim Das, whether the name of Nilim Das was recorded in the Office of BL & LRO or not?
 - iii) In the year of 1985, the name of Aswini Kr. Sau was recorded as Bargader. Yes/No. If yes, inform me the name of Rayat (Owner) of this land.
- b) The SPIO provided information to the appellant vide memo. 1038/RTI/Tam-1/24 dated 28.10.2024.
- C) a) Appeal no. 101610/2025 date of RTI 25.09.2024 filed to the SPIO, BL & LRO, Tamluk-I for seeking the following information -
- i) When Khatian No. 221/1 of Neelima Das was recorded in BL & LRO office? When that record was available? Give me details.
 - ii) When Khatian No. 161/1 of Tanmoy Das was recorded in BL & LRO office? Give me details.
- b) The SPIO provided information to the appellant vide memo. 1037/RTI/Tam-1/24 dated 28.10.2024.

2. Grounds for second appeal were dissatisfaction with the reply of SPIO and relief sought for is to provide the complete information.

Deliberation and Decision

3. The appellant was present in person. Shri Sumit Kr. Basu, Executive Officer, Tamralipta Municipality, Tamluk was also present in person. Shri Soumyabrata Das, BL & LRO, Tamluk-I, Purba Medinipur was present virtually.
4. The three RTI applications filed by the appellant were discussed as following :
 - i) RTI application dated 03-4-2024 filed with SPIO, Tamralipta Municipality vide para 1 (A) above
 - a) It is seen that the SPIO e-mailed the reply to the appellant on 13-02-2026. The appellant also admitted to have received it but has not been able to check it for the last three days as he was busy with urgent work. The Commission noted that there is a plot of land [Dag No.494]. Eight decimals of the land was given in 'Patta' by the government to one Aswini Kr. Sau. The rest of the plot /land has been bought by the appellant. Later, the appellant got a building plan sanctioned by the Tamralipta Municipality. Now, he has a grievance that Aswini Kr. Sau filed a WPA in the Hon'ble Calcutta High Court on 12-10-2023 for illegal construction against the appellant. This caused harassment and embarrassment to the appellant and he filed the instant RTI application and a case with the Land Tribunal. He pointed out that Aswini Kr. Sau got a building plan sanctioned on his 8 decimals plot. As per the appellant's information, there was an old structure and on that old structure the Tamralipta Municipality sanctioned a building plan. The Tamralipta Municipality replied vide memo no.1693 dated 13-02-2026 wherein it has been mentioned that the Municipality has sanctioned a


building plan. The appellant has a grievance that the Municipality has sanctioned building plan on a plot where an old structure was standing and this sanction by the Municipality is illegal. It was explained to the appellant that the RTI Act is not for redressal of grievance but only for supply of information. For redressal of his grievance, the appellant may approach appropriate forum / Authorities. The Commission noted that there has been a case and counter-case between the appellant and Aswini Kr. Sau in the Hon'ble High Court and WBLRTT etc. The Commission noted that the appellant has been replied adequately. The case is closed.

- b) The SPIO submitted that the appellant has filed nine to ten RTI applications on the same / similar issue.
- ii) RTI application dated 24-9-2024 filed with SPIO, BL & LRO, Tamluk-I vide para 1 (B) above
- a) It is seen that in query no. (iii), the appellant is seeking to know whether Aswini Kr. Sau was 'Bargadaar' in 1985. The SPIO submitted that records showed Aswini Kr. Sau as 'Bargadaar' since 1964. He further added that it was a mistake on his part saying that the particular year could not be affirmed. Logically, Aswini Kr. Sau should be 'Bargadaar' in 1985 also. The Commission noted that the appellant has been adequately informed and replied. The case is closed.
 - b) The SPIO submitted that the appellant has already filed ten to twelve RTI applications.
- iii) RTI application dated 25-9-2024 filed with SPIO, BL & LRO, Tamluk-I vide para 1 (C) above

- a) It is seen that in reply to query no.(i), it has been mentioned that it is not possible to affirm. The SPIO explained that the date is not legible in the record as it is a very old record. On being asked by the Commission to make a personal inspection of the record in the office of the SPIO, Tamluk, the appellant refused and stated that he already has the copy of the land-records.
- b) Query no. (ii). The appellant stated that he did not get the reply. The SPIO reiterated the earlier reply that the date is not clear in the record. The record being very old has become illegible / unreadable. The appellant was asked to have an inspection of the record but the appellant again refused and stated that he has got the copy. The Commission noted that the appellant is adequately informed. The case is closed.

5. Regarding multiple RTI applications filed by the appellant vide para 4 (i) (b) and 4 (ii) (b) above, the appellant is advised to use his right under RTI Act conscientiously keeping in view the spirit of the RTI Act and judgement of the Hon'ble Supreme Court in Aditya Bandyapadhyaya vs CBSE wherein it is said that it is not expected that the majority of the employees of the Public Authority will waste majority of their time in replying to RTI applications.

6. The matter is disposed of.
