**Facts on Record & Findings :**

The SPIO of the case is present for hearing in virtual mode. The authorized representative of the appellant is present for the hearing physically.

2. The appellant filed an RTI application on 28.04.2022 seeking three points of information regarding incorporation of name of one Greeta Kumari Yadav in the death certificate of Late Ramoo Prasad Yadav. The appellant in her RTI application claimed to be wife of the Late Ramoo Prasad Yadav and wanted to know the ground/ documents relied upon, on the basis of which name of Greeta Kumari Yadav was entered as wife of Late Ramoo Prasad Yadav .

3. Not getting any information, the appellant filed first appeal before the First Appellate Authority on 28.06.2022. The First Appellate Authority seems not to have done anything of the first appeal. Dissatisfied, the appellant filed second appeal before the Commission on 10.11.2022.

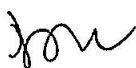
3. No reply seems to have been given by the SPIO to the appellant as per case record and also as per submission of the SPIO during the hearing. The SPIO however, vide letter Dated 04.06.2025, asked the Sub-Registrar (birth-death), Debanandapur Gram Panchayat, Bandel in Hooghly District to submit an action taken report on the RTI application and also requested him to attend today's hearing.

4. When the Commission asked the SPIO to furnish the reason for not submitting any reply, he quoted the aforesaid memo Dated: 04.06.2025 sent to the Sub-Registrar as noted above. It therefore appears that while the SPIO did not take any steps to furnish any reply to the appellant, after receiving notice for today's hearing, he simply passed on his responsibility to some other official. The said letter Dated:04.06.2025 addressed to Sub-Registrar, Debanandapur Gram Panchayat is bad in law as under section 6 (3) of the RTI Act, 2005, any transfer of RTI application has to take place within five working days and at this stage, after lapse of two and half years, no such transfer can take place. The SPIO is accordingly directed to obtain requisite information from the above mentioned Sub-Registrar (birth and death) or any other authority holding such information, by using his powers as vested in him as SPIO under section 5 (4) and 5 (5) of the RTI Act, 2005 and then furnish information so obtained to the appellant. This exercise should be completed within next six weeks. The Commission should be informed compliance of the same.

5. The matter will be taken after six weeks or receipt of compliance report from the SPIO whichever is earlier.

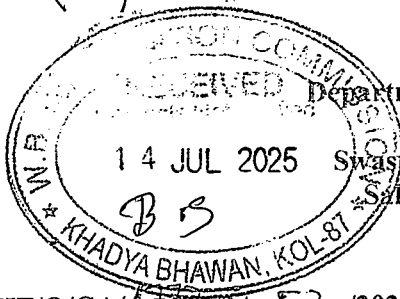

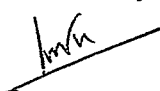
