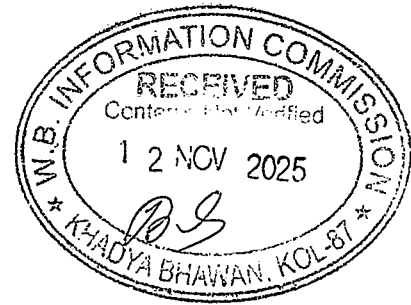

**Subject :** - Second Appeal under RTI Act, 2005 against the Order / Memo No. 6186 - E dated 24.09.2025 of Shri Praveen Kumar Tripathi, IPS, Commissioner of Police & Appellate Authority, Howrah Police Commissionerate ( Xerox copy enclosed ) copy enclosed ).

#### Details of the Case : -

The Appellate Authority, Shri Praveen Kumar Tripathi, IPS, Commissioner of Police, Howrah Police Commissionerate, vide order / Memo No . 6186 - E dated 24.09.2025, disposed of the first appeal filed by the appellant against the incomplete response provided by the SPIO, Howrah Police Commissionerate. The appellant is aggrieved by the said order and seeks intervention of this Hon'ble Commission.

#### Grounds of Appeal:

1. The Appellate Authority failed to appreciate the incomplete and unsatisfactory response provided by the SPIO, which did not address the queries raised in the RTI application dated 25.08.2025 .
2. The order passed by the Appellate Authority is cryptic and lacks reasoning, failing to provide a clear justification for the decision.
3. The Appellate Authority did not ensure that the SPIO provided complete and accurate information as per the provisions of the RTI Act, 2005.

#### Reliefs Sought:

1. Please direct the SPIO, Howrah Police Commissionerate, to provide complete and accurate information sought in the RTI application.
2. I request also that the SPIO, Howrah Police Commissionerate, carefully review ten nos. (10) of appeals directly related to GD No.334 dated 07.09.2024 registered in Bantra PS. The SPIO's response to my RTI appeal dated 15.09.2025 suggests that they only considered the subject of my appeal i.e the GD, not the actual content. This casual approach is concerning, especially since I sought information not just about the GD but also about the appeals of me and my wife Smt Joly Bhattacharjee highlighted in the RTI application."

Respected Sir ,

I am writing to request information in terms of RTI Act, 2005, regarding the 'Final Report' of the investigation of GD No.334 dated 07.09.2024 registered at Bantra PS under HPC/WB which is under your jurisdiction so far my knowledge which is related to a "Social Media based Cyber Crime allegation" against the undersigned by Sri Somnath Das and his family on 24.08.2024 and later on the same allegation against my wife Smt. Joly Bhattacharjee also on 29.11.2024, and also related to the appeals in connection with the same dated

24.08.24 , 27.08.24 , 07.09 24 , 01.12.24 , 03.12.24 , 13.12.24 , 15.01.25 , 12.02.25 , 21.03.25 , 21.05.25 to OC / Bantra PS , Higher Officials including Honorable CP of HPC, OC / Bantra PS , Cyber Crime PS , Hon'ble PC, DCP ( N ), DCP ( N ), Hon'ble PC respectively of myself and my wife jointly .

Specific Information requested :-

- 1) Current Status of the Investigation :-
  - i) Please provide the concise overview of the Final Report of the investigation since respected DCP ( North ) / IPS / Howrah intimated to me and my wife Smt. Joly Bhattacharjee verbally on 03.01.2025 by saying that original culprit had already been identified by name and he also told us that the case was not of Hacking or cloning but rather misuse of our phone numbers only . And he also requested us not to expose the name of the actual culprit .
  - ii) In connection with the Para (i) above, please provide also a concise overview of the investigative action taken so far against the 'identified culprit' by name in this connection, including evidence collected, or investigation conducted .
  - iii) Also please provide me the recorded information received from META by Cyber Crime Dept. / HPC / WB regarding our innocence and non-involvement with the "Social Media based Cyber Crime" in connection with our Facebook Accounts which was shown to the Complainant against their allegation against me and my wife Smt Joly Bhattacharjee by the IC of this case and that same information was also communicated verbally to me and my wife Smt Joly Bhattacharjee by the IC of this case of Cyber Crime Police Station / Howrah under HPC /WB on dated 07.01.2025 .
  - iv) If the statement from the concerned Dept. of HPC does not seem to be true narrated above in para (i), (ii) and (iii) by me only on the basis of verbal statement of the overall In-charge of Cyber Crime Department the respected DCP (N) / Howrah on 03.01.2025 and IC of the case of Cyber Crime Dept./Howrah on dated 07.01.25, then please provide a detailed account of the current status of the investigation .

v) Also please provide a detailed account of the current status of the investigation against my written complaint dated 02/03.12. 2024 to OC / Cyber Crime Police Station/Howrah and intimated also to Hon'ble PC of /HPC about sending of ugly and shameful message by some "Aami Khokan" in the messenger of my Facebook Account on dt. 30.12.2024, which was almost like verbal abuse against me and my wife Smt. Joly Bhattacharjee on the day of occurrence of the fact i.e. 23.11.2024 in front of near about 100 local neighbours of our area at the time of an enquiry by the Police Officials of Bantra PS, Howrah.

vi) Sir, as a concerned senior citizen, I seek the above mentioned informations under the RTI INFORMATION ACT ' 2005 for the reasons stated below :-

- For ensuring transparency and accountability of Police Administration,
- For regaining our social respect,
- For getting relief from mental anguish we have been suffering since 24.08.24 till today, as we have not received any response to our multiple requests to the Police Administration of HPC to know the progress or outcome of the investigation into the Social Media based Cyber Crime against us.,
- And also as senior citizen couple (69 yrs. & 60 yrs.), we can spend the rest of our life peacefully, free from the false allegation which has already been proven in the context of the above-mentioned Cyber Crime related case, subject to the verbal Statements of the Hon'ble DC ( North ) / Howrah and IC of this case of Cyber Crime PS / Howrah Police Commissionarate, as mentioned in para (i) and (ii).



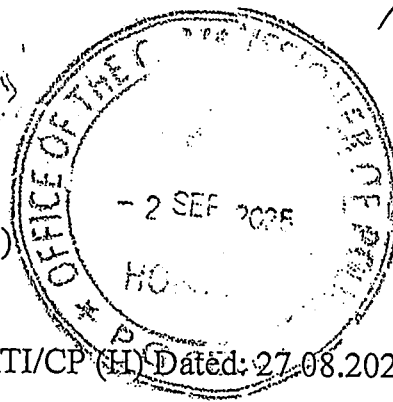

Respected Sir ,

I am writing to appeal against the response to the Memo No . 5891-E dated  
 09.09.2025 provided by Dy. Commissioner of Police (HQ & SPIO of Howrah Police  
 Commissionerate in response to my RTI appeal dated 25.08.2025 received by the  
 undersigned on 11.09.2025 .

The grounds for my appeal are appended below :-

- 1) The response only addresses the GD entry and doesn't provide information regarding my written appeals to the Police Administration of Howrah Police Commissionerate as requested in my RTI appeal dt. 25.08.25 .
- 2) In this aspects , please have a look on the first para of my appeal dated 25.08.2025 and also item (v) of ' Specific Information requested ' so that , as a RTI Applicant I can get the proper and a complete response to my said RTI appeal.
- 3) Sir , as a First Appellated Authority the following points may please be noted raised by the undersigned as a RTI Applicant :-
  - i) The Officer-in-charge of Cyber Crime Police Station of HPC informed to the DC ( HQ ) , IPS/HPC & SPIO / HPC that they couldn't find any data related to GD No. 334 dated 07.09.2024 registered at Bantra PS . Due to this , they couldn't provide assistance to Bantra PS as per DC (HQ) & SPIO/HPC's Memo No.- 4165(2)/PG/RTI/CP(H) Dated : 27.08.2025 .
  - ii) In connection with the point (i) above I have to mention here that Myself and my wife Smt Joly Bhattacharjee appeared before Respectable DC ( North ) on dated 03.01.2025 as per his call message vide Org No.- 540/DCP(ND)/HPC/24 Dt :- 23.12.2024 . This was in connection with my appeal / petition dated 13.12.2024 addressed to Respectable Commissioner of Police/ HPC. I had enclosed a filled-up form related to "Social Media Related Crime" vide Encl . No.( 4 ) provided by the Cyber Crime Department/HPC which mentioned Police Station Bantra, GD No.334 and dated 07.07.09.24 (Xerox copy enclosed).

iii) It seems logical to note that if the DC ( North )/HPC , as the overall In-charge of the Cyber Crime Department/ HPC , is aware of the said cyber-crime issue and the details of the GD , then his Departmental Head and office should also be aware of it . This is because they are the custodians of the correspondence related to Cyber Crime case as per the official system.

iv) On the contrary , in respect to the RTI reply dt.09.09.2025 based on the letter of Officer-in-charge of Cyber Crime Police Station dt.07.09.2025 against my RTI appeal dated 25.08.2025 seems to be very much contradictory .

The Officer-in-charge of Cyber Crime Police Station/HPC is making contradictory statements: On one hand, he claims to have no data about GD No. 334 dated 07.09.2024 registered at Bantra PS, which prevented him from assisting them. On the other hand , he says he assisted Bantra PS regularly regarding the same cyber-crime issue mentioned in the RTI appeal dated 25.08.2025 of the undersigned related to the GD .

The above mentioned issue must be dealt by the Cyber Crime Department/HPC and may be monitored by Bantra PS since it is " Cyber Crime Related " which was also confirmed verbally both by the Bantra PS/HPC as well as Cyber Crime Department/HPC. My experience as a retired Mechanical Engineer of Indian Railways can also speak for the same mentioned above .

As a responsible Senior Citizen couple, we have submitted all our applications and all the information related to our applications to the Cyber Crime Department as per their directives with utmost faith and trust without having them sign our personal copies.

Despite not having any receipt copies with us , the positive and helpful attitude of the officials of that department made us believe that they were the only safe custodian of our original applications and informations with the help of which we would get justice against the false allegation to us after a proper investigation .

In this situation, at present in view of the incomplete and contradictory reply of SPIO/HPC to my RTI appeal dated 25.08.2025, I am constantly hesitant to trust the Police Administration of Howrah for a proper investigation and the hope of getting a fair trial.

Because, if the specified Department of the Police Administration regarding " Cyber Crime" is unable to properly preserve the information provided either by any applicant or by the other Department of Police Administration , then on what basis will they be able to conduct a investigation, it is not clear to me as a ordinary retired Mechanical Engineer of Indian Railway.

Also , in connection with the above I want to mention that since August 2024 whenever myself and my wife visited the office of the Cyber Department/HPC seeking justice for a false accusation against us regarding a " Social Media based Cyber Crime " , we have noticed a common practice . The department often accepts applications and receives required information from the applicants without providing any acknowledgement of receipt on the personal copy of the applicants. Myself and my wife have had the same experience.

Although I appreciated in my earlier appeal that the officials are very polite and sensitive I already mentioned in my earlier appeals to the Officials of HPC.

4) In my RTI appeal dated 25.08.2025, I specifically requested for information about current investigation status of my case. I asked if the statement I was given by the higher officials, verbally, doesn't seem to be true, then please provide details on whether the investigation is ongoing or concluded.

I request you to direct the respected DC (HQ)/HPC & SPIO/ HPC to provide a complete response to my RTI appeal dt. 25.08.2025, including details of any actions taken based on my GD entry and subsequent written appeals which are already highlighted in the first para of my appeal dt. 25.08.2025 and copies of any documents or correspondence related to my case including the correspondence with META.

I, Kisshor Bhattacharjji resident of HIT Quarter Type-IV Block 20 Flat No.-3 Dumurjala Housing Complex, Howrah-711101, would like to get your kind attention to the fact that a fake facebook profile has been created by any person, unknown till date, using my personal mobile number and a young girl's photo as profile picture and nasty, ugly, shameful and uncivilized posts are being circulated using this account since 23<sup>rd</sup> August, 2024 which is completely out of my knowledge. I could not even think about it.

In this connection this is to be intimated to you that the complainant has not given any copy of the same even after my request. This is as per the verbal conversation communicated to me by Sri Somnath Das and Smt. Rama Das. They only show the mobile screen from distance where I can view my mobile number and that young girl's picture only. On the basis of that I already have lodged a written complain to my related police station i.e. Bantra PS and also communicated the fact to Cyber Crime Department of Howrah PS as well as Lalbazar over mail on 24<sup>th</sup> August, 2024 which is in the trailing mail below. Please find attached a copy of the same for your kind perusal. I, further, would like to inform you that on the next day i.e. on 25.08.2024 I with my two cousins went to the Cyber Crime Department of Howrah PS to submit a hard copy of the letter dated 24.08.2024 which has been submitted to Bantra PS at around 12 to 12:30 PM. The concerned lady officer on duty attends me in her closed door chamber under CCTV surveillance and listen the synopsis of the fact very patiently. Then after she told me very politely that as per system they are unable to receive the copy of the same from myself. They will investigate the same only after receiving the case forwarded by Bantra PS.

Now I am coming to the details about the incidents happened during 23.08.2024 and 24.08.2024. The parents of that girl came to me on 23.08.2024 morning for asking me why am I doing this, on the first day of occurrence of the fact. I tried to brief them that I am not at all involved in this act and ask them to report the same to Cyber Crime Department of Police. In this situation I primarily tried to go to police station on that very next day i.e. on 23.08.2024 for giving intimation of that fake facebook account and its posts to prevent myself as well as their family also. But due to my illness and water logging all around our housing complex I could not go there. But after the whole fact occurred on 24<sup>th</sup> I have to go to the Police Station and found that they already reached there for lodging allegation/complain against me, though this is not the first incident of this type with that family. In that incident my profile was not connected in any manner. They came to me for advice to resolve that matter. And then also I advised them to go to Cyber Crime Depart of Police.

As a senior citizen of 68 years and as a cardiac patient (since 2017) and a patient of panic attack (since 2011) and also a patient of spondylitis and loss of lumber lodosis, I am requesting to your good-self with folded hand to get rid of the mental harassment done by the complainants and their associates of Block-20, Type-IV of HRBC Housing Estate, Dumurjala and the investigating police personnel of Bantra PS regarding " misuse of my facebook account, using my mobile no. 8584032634, by sending nasty massages" to a young lady, not even reaches her adolescences who was also like my grand-daughter and very very much good relation before the said incident. Though the case is now under investigation of Cyber Crime Department under you. Whenever we have visited (at least 6 to 7 times) they verbally assured us "not to be worried so much as because both the appeals, of complainants and yours already forwarded to them and the Bantra PS is not concerned now with this case as the case is now under us and it is a "Cyber Crime". And they also told that if again the same occurrence would be happened then the said complaint might be forwarded to them for inclusion with the same case."

Sir kindly advice your good office to go through this type of lengthy appeal which is a last hope to myself and my wife to get rid of our extreme mental agony.

Sir. As a retired Mechanical Engineer I have no knowledge about the IPC under newly constituted act under 'Bharatiya Nyaya Sanhita'. But as per my common logic I realise that I have to narrate everything to get rid of these type unnecessary harassment before completion of the said investigation.

The very first day when we arrived at Bantra PS the officer-on-duty didn't want to listen our problem other than to fire me such a way that I had already been proved guilty only on the basis of the complaint received from complainers which had been lodged just before our arrival. They didn't also agreed to receive a General Diary from us other than only to submit my appeal dated 24.08.2024 in receiving section of the Police Station. He also not believed

...ing my on-going cardiac and sleep-apnea treatment rather than criticise me based on own assumption and over-view in spite of my attempt to show the medical papers which were enclosed with my said appeal dated 24.08.2024 and also mailed in their official mail address as well as concerned Cyber Crime Department too.

Though the receiving official of the PS informed that the letter would be forwarded to Cyber Crime as per system in vogue, two officers from Bantra PS came to my flat on 07.09.2024 to interrogate me for repetition of said incident only on the basis of a complaint and more specifically threaten me without any proof or evidence against the said cyber-crime.

After the said event I lodged a General Diary (9GD No. 334 date 07.09.2024) and reported the same date to the Cyber Crime Dept. to block my facebook account immediately in a prescribed Form given by them.

Again on 29.11.2024 the same incident occurs using a fake facebook account in the name of me and my wife against a written complaint by the same complainant, 7 to 8 officers from Bantra PS came to our block premises in the name of enquiry. But instead of enquiry they more intended to blame us and treated as criminals before it has been proved by the Cyber Crime Dept. till that date that whether we are actually organised the crime or involved in any means. The said officer indulged the complainants to be more aggressive on us and suggested them to make an FIR against which they can arrest us and put us in jail custody. As a result the complainants and their all other associates of the block were more and more got on us with slang, inaudible languages and humiliating both of us in front of the officers and public gathering and my local other well-wishers who came only to give us support keeping our old age and health condition in mind. The officers during that time were there only as spectators rather than to stop them and protect me as a senior citizen when I was expecting the support from them as per human rights then.

In this regards I should have to mention that which I have narrated to some extent (as the version of languages used by them was so nasty it could not be mentioned here) in the appeal could not be submitted, as it couldn't be recorded neither by me and wife nor my well-wisher cum witnesses due to build-up of a violent situation, as a proof.

Now the question is that-

- 1) I don't know that whether the great initiation taken by Howrah Police Commissionerate in the year 2018 to honour and extend support to the senior citizen, named "SHRODDHA", is still exist or not. In terms of said initiative can I not expect the minimum respect and support from the same Police department?
- 2) The said case is already forwarded to concerned Cyber Crime Department as per the system in vogue of your department and then onward I am directly transacting the details and the complainants have also lodge their complain with them. Now my question is that how the local police can come to my flat again and again on the basis of mere written complaint without intimating the same to the Cyber Crime Department as the case is under their on-going investigation? Now I am very much confused whose instruction to be followed, either of the local PS or Cyber Crime? The question is being raised that so far as my knowledge we are under the jurisdiction of Bantra PS as a whole but in this case itself now we are under the jurisdiction of Cyber Crime.

3) Now one more question of mine that am I so foolish to do this type of mischief repeatedly by using my mobile numbers, as blamed by the officers and complainants, when I, on the very 1<sup>st</sup> day i.e. on 24<sup>th</sup> August, 2024, have submitted my appeal highlighting the said mobile nos., being a retired South Eastern Railway Mechanical Engineer having 5 times CME and 1 time GM award?

I like to say that this is not an allegation against the investigating police personnel but may be taken as my reasonable question as per basic human rights of a senior citizen.

One of our well-wisher presently now a higher official of Howrah Municipal Corporation and ex-councillor of our area and still now be helpful to all the residents of our municipal ward including our HRBC Complex also, asked us to visit his office at his own residence after seeking help by my wife over phone on that very night i.e. on 29<sup>th</sup> November, 2024, not finding any other way to save a heart patient as well as a patient of panic attack. On the very next morning i.e. on 30<sup>th</sup> November, 2024 we along with our well-wishers and friends and eye witnesses visited his office where he also agreed with our arguments mentioned above and request me to visit the Cyber Crime Department on that very day immediately as he is aware of my social activities and reputation in the society and subsequently make you aware regarding all that matters, if we think, after feeling our heart-broken mental state.

Sir, not take it as a threat from a senior citizen of 68 years and my wife of 59 years, if these type of incident occurs again and again we may have to take a extreme decision about closing of these on going chapter of humiliation permanently, otherwise.

At last once again with folded hand we request your kind attention in this matter to save us and oblige.

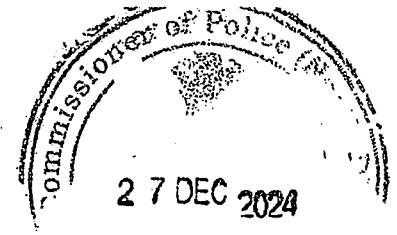

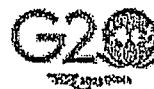



Sir, we were informed verbally, after completion of the investigation about our non-involvement with the "Social media based cyber crime" by respected D.C.(N), respected C.C.(Cen), and IC of the case i.e. Madam Debjani of Cyber Crime Department, Howrah on 03.01.2025 and 07.01.2025.

Sir, after facing this type of occurrence first time in my life, I experienced that like other Government Office / Administration, the Police Administration also doesn't take any action against any verbal complaint of any one without any written appeal which has to be registered in their records as per system in vogue.

In the same analogy I think that we also have the right, as a citizen of India, to get a "Written Clean Chit" or a "Written document" from the Police Administration regarding our non-involvement against the written allegation raised by Sri Somnath Das and his family.

In connection with the above, I must have to mention that realizing my husband's (68 yrs.) physical as well as mental health condition they also counselled us very politely so that from that time both of us could live normal life without any mental agony since the actual culprit was already identified and they also assured us that from then onwards no one would disturb us including any Police Personnel from local Police Station regarding this particular allegation. Since then we have not been harassed or bothered by anyone in this regards.

The "Written Clean cheat" / "Documented Intimation" in this regards is very much essential for us, as per my common sense as a general civilian, due to the reasons which are appended below :-

1 ) The Written allegation raised against us and our several appeals and the prescribed forms signed by us about our case related personal information, as asked for, during investigation had been recorded officially in the offices of the Police Department.

But, Sir if we are not being provided by your good office the "Written Clean cheat" after completion of the investigation then we may face the same type of trouble in future as because any verbal intimation or information does not have any value and can't be treated as a legal proof of our non-involvement with any particular Social Media based Cyber Crime like this.

In connection with the above, I would like to inform you that we destroyed our Mobile SIMs, prevailing at that time, under the pressure of some Police Officials of Bantra PS with stubborn and harsh attitude on 29.11.2024 and then started to use new Mobile Nos (SIMs) after surrendering the old SIMs which had been informed to the Cyber Crime Department in writing.

In this regards, again I am saying that the "Written Clean Cheat" is very much important to us in future as because if someone tries again, intentionally, to misuse our new Mobile Nos. to defame our social reputation and identity in this age then at least we can produce the Copy of the same as an example and as a primary protection.

3 ) Some of the so-called educated persons and ignorant people regarding Cyber Crime in Social Media are still in a dilemma whether we were involved or not. So, the Written Documented Intimation is also necessary to convince them as they witnessed the occurrence on dated 29.11.2024 evening when we were being threatened by the officials and the Complainant and their associates.

In view of the above, I would like to inform you that we already quit ourselves from the Social Media Activities like Facebook, Whatsapp etc. with an official intimation to the Cyber Crime Department/

Sir, even after making obscene and insulting taunts by the Complainant to an aged lady in front of the Police Personnel of Bantra PS and a huge public gathering then, I didn't insist my husband to approach to the Court according to the law to protect a woman from harassment and insult under Bharatiya Nay Sanghita after filing an FIR, rather than to suggest him to send an appeal to your good self with a hope to save us. The behavior they showed was very much humiliating and painful to a senior citizen and elderly lady at that time as well as when they met us in our flat in the name of enquiry on 07.09.2024 and 29.11.2024.

Last of all, I hope that you will be kind enough to advise your related Department to provide us the " Written Clean cheat " / " Documented Intimation " consisting of only two to three lines only regarding non-involvement of us against the Cyber Crime related allegation raised by Sri Somnath Das and his family with a copy to the Complainant.

Though, I don't know whether you or your departmental officials have the enough time to go through this lengthy appeal. But, I can say that this appeal is merely an attempt to relieve the long-term mental anguish caused by the unjustified loss of social respect.

In this regards, we consider ourselves fortunate that the bitter experiences of the first phase of investigation, although not completely forgotten, has been somewhat alleviated by the sincere and compassionate behavior of the higher Police Officials in the later stage of the investigation.

Use of any illegal word or sentence used by myself due to my ignorance as a housewife in this appeal, if any, may please be regretted.
