- xii) Is there any provision to take action against any headmaster/headmistress of any primary & secondary schools who do not submit requisition for stipend of SC/ST & OBC of his/her school?
- xiii) Is there any provision to take action against a chair person who fail to send application form of stipend SC, ST, OBC student and the children of unclean occupation to primary & secondary schools of his jurisdiction?

2. OC, BCW, Barrackpore sent a reply to the appellant vide memo no. 692/BCW/BKP dated 20.06.2022.

3. Grounds for 2<sup>nd</sup> appeal are dissatisfied with the reply.


4. SPIO Bidhannagar sent reply to the appellant vide memo no. 946/BCW-SDO/BDN dated 15.12.23.

Deliberations and Decision :

5. The appellant is present in person. SDO, Bidhannagar & SDO Barrackpore both SPIOs are present virtually.
6. The SPIO Barrackpore replied vide para 2 above. The SPIO Bidhannagar submitted that he has already replied to the appellant yesterday by e-mail also.
7. The Commission noted that the appellant has filed 13 queries in the RTI application. All the queries in the RTI application are vague, general, wide, omnibus and reply to such queries will not serve any public interest and nor any bonafide personal interest. This is mere a harassment of Public Authority and at the same time a misutilisation of RTI Act. These queries are violation of
  - I. S 6 (1) of the RTI Act wherein it is said that there is a request. It implies that there is a specific request.
  - II. S 7 (9) of the RTI Act wherein it is said that the resources of the public authority should not be disproportionately diverted.
  - III. Preamble of the RTI Act wherein it is said that the Govt. has to be allowed to work and meagre resources of the Govt. should not be wasted.
  - IV. Judgement of the Hon'ble Supreme Court in case of Aditya Bandyapadhyya vs. CBSE of 2011 wherein it is said that RTI Act has not been framed with the intention that majority of the staff of the Public Authority is busy for majority of time in replying to the RTI application only.
  - V. Judgement in the case, Shail Sahni Vs. V. S. Mathew & others (Delhi High Court, 2016), wherein it is said that wide, voluminous & general information are not to be provided. Therefore, these need not be replied.

These needed not have been replied. However, the SPIOs have replied. The Commission noted that the appellant has been replied adequately. The case is closed.


