



2. Copy of report from SP, Bonagon as asked by the DIG (Legal), WB vide Memo No.378/Law Cell dated 01.04.2024.
3. Report of Sub Divisional Police Officer, Bongaon Police District, WB.

The DIGP, Legal, WB was asked for information U/S 5(4) & 5(5) of the RTI Act, 2005 by the SPIO, WBPD & IGP(O), WB. After receiving the information from the DIGP, Legal, WB, the same was communicated to the applicant by the SPIO, WBPD & IGP(O), West Bengal Police Directorate vide this office Memo No.313-ADM/RTI dated 23.07.2024 within the statutory period and the same has been received by the applicant.

The petitioner preferred 1st appeal dated 06.08.2024 which was received on 08.08.2024.

He has made this appeal with a request to provide a copy of the enquiry report submitted by the SDPO and SP, Bongaon Police District upon his complaint.



Appellate Order


