Sir,

Enclosed please find a copy of the RTI application mentioned *ibid*, marked A-1. I have been provided false and misleading information by the 3<sup>rd</sup> party, Jt. Registrar of Co-operative Societies, Kolkata Metropolitan Area Housing (JRCS, KMAH), as forwarded by the SPIO & Addl. Registrar of Co-operative Societies, Co-operation Directorate, marked A-2.

I have filed the 1<sup>st</sup> appeal, marked A-3. The AA was kind enough to dispose off my appeal on 26.07.24 with the direction upon the 3<sup>rd</sup> party, JRCS, KMAH to furnish the information within 10 (ten) days of receipt of the order, to the SPIO, marked A-4. But the JRCS, KMAH on 09.08.24, reiterated the same misleading and false information and the same was forwarded by the SPIO to me, marked A-5.

Ground for appeal – The information sought for related to formation and presently functioning of an Interim Committee (IC) of Bengal Soroshi Housing Co-operative Society Limited (BSHCSL) for which a request was made by the then Secretary, BSHCSL, Smt. Bratati Raybardhan with the concerned JRCS, KMAH. The letter dated 01.04.21 was delivered by hand on 05.04.21 to that office and received by one Shri K. Das, as clearly evident from the receipted copy of the letter, which was also provided with the 1<sup>st</sup> appeal, marked A-3, pg 3. But, the 3<sup>rd</sup> party, JRCS, KMAH stated that the said letter dated 01.04.21 of the BSHCSL has not been found in his office, as such, no information related to the formation and functioning of the IC are available at his end.

Relief sought for - Initiate appropriate steps under the RTI Act, 2005 and ensure that the desired information is provided immediately and initiate stringent steps against the JRCS, KMAH for providing false and misleading information by a public servant.

Sir,

In connection with the constitution of an Interim Committee (IC) of Bengal Saroshi Housing Co-operative Society Ltd (Regd. No. 01/KMAH of 2005) in 2021 by the department, please provide me the following information/ decision:-

1. Whether the declaration/undertaking in respect of the three present office bearers of the IC, namely, Shri Somenath Banerjee, Secretary, Smt. Papiya Baishya, Chairman and Shri Prosenjit Biswas, Treasurer, whose names were recommended by the outgoing Secretary, checked/ verified by the dept. before according approval to their recommendation? If not, on what basis it was accepted to be true?
2. On what basis of Rules/Act, a non - resident member can hold office as Secretary of the said housing society, who has never stayed for a day since allotment of his flat no. B-2 by the society and has been letting out throughout on rent till date violating Sec. 93 of the WBCS Act, 2006, by even non-payment of any tenancy charges to the society?
3. Can a member hold office as Chairman who has not paid any tenancy charges in respect of flat no. C-5 in the society which she had taken on rent for more than 10 years?
4. Is it permissible to throughout let out a flat allotted to a member who has sworn on affidavit of his need for genuine accommodation under Sec. 87 of the WBCS Act, 2006 and violation of which is an offence under Sec. 149, Fourth Schedule of the Act?
5. What is the present tenure of the present IC? Whether any steps initiated by the dept. for reconstitution of a regular Board of Directors during the last three years? If not, please provide reasons for the delay.
6. Whether the fact of the (i) non -resident status of the Secretary, and (ii) Chairman being defaulter of tenancy charges, ever brought to notice of the dept. by any member including office bearers during the last three years? If so, please elaborate.

The requisite fee of 10/- for furnishing the information, in the form of court fees stamp is  
attached. If it appears that the required information does not pertain to you, please the provisions of  
Section 6(3) of the RTI Act, 2005 may please be followed. It may also please be considered to  
provide alongwith the reply to my request, the name, designation and address of the Appellate  
Authority with respect to your file, where I may file my first appeal, if denied.





**Sub: - 1<sup>st</sup> Appeal under section 19(1) of the RTI Act, 2005 – misleading and false information provided against RTI application dated 04.06.2024.**

Sir,

Enclosed please find a copy of your office letter no. DCOOP-16015/1/2021 – RTI CELL – DCOOP/1/531034/2024 dated 02.07.2024 forwarding replies to my RTI application dated 04.06.2024 as provided by the JRCS, KMAH Cell vide memo. No. 544/IX-01/05/KMAH dated 14.06.24. I am aggrieved on being provided false and misleading information and surprised due to the following reasons: -

- 1. Regarding query no. 1**, a scanned copy of the letter of the Bengal Soroshi Housing Co-operative Society Ltd. dated 01.04.21 is enclosed which is receipted in the O/o the JRCS, KMAH on 05.04.21 and bears the office seal/stamp of the office. It transpired therefrom that names of the present office bearers were recommended and formation of an Interim/nominated Board was proposed by the then Secretary, Smt. Bratati Raybardhan, which was approved by the JRCS. The declaration/undertaking in question in query no. 1 is contained therein. But, it has been denied that the information is available in that office though fact remains that the information is existing and available with the JRCS.
- 2. Regarding query nos. 2 to 3**, it is the statutory duty and responsibility of the JRCS (KMAH) to ensure compliance to the W. B. Co-operative Societies Act, 2006 and W. B. Co-operative Societies Rules, 2011 by all Housing Co-operative Societies registered under him and the queries pertain to approval accorded by the JRCS, KMAH to the nomination of Chairman and Secretary of the present Interim Committee (IC) constituted by him, **in violation of provisions of Sec. 87, 93 and 149, Fourth Schedule of the WBCS Act, 2006. As such, the JRCS is liable to provide the desired information on his statutory duties.**
- 3. Regarding query no 4**, it is clear violation of Sec. 87 of the WBCS Act, 2006 by the Secretary of the IC constituted by the JRCS, which tantamount to offence under Sec. 149, Fourth Schedule of the Act and the JRCS, KMAH is the public authority entrusted with ensuring compliance to applicable Act/ Rules by Co-operative Housing Societies. Hence, the JRCS is liable to provide

clarification on approval of ineligible Offender member by him as Secretary of the IC, also constituted by him, which is not permissible under any Act/ Rules applicable to the society.

4. **Regarding query no. 5** regarding the tenure of the Interim Committee constituted by the JRCS, it has also been stated that the information is not available with that office. It is surprising that the JRCS is having no knowledge of the tenure of the Interim Committee constituted by him.


