

7. Details and Grounds for First Appeal u/s 19(1) of the RTI Act, 2005 preferred by the appellant and the relief sought for :

(a) Being aggrieved and/or not satisfied by the reply of the State Public Information Officer, Office of the Registrar of Assurances, Kolkata dated 21.06.2024, being Memo No. 986, the applicant preferred First Appeal u/s 19(1) of the RTI Act, 2005 before the Central Public Information Officer, Inspector General of Registration, Fortuna Tower at 23A, N.S. Road, 9th Floor, Kolkata – 700001.

(b) The First Appeal was preferred by the applicant on 15.07.2024 and the same was sent through speed post which was delivered on to the First Appellate Authority on 16.07.2024.

(c) Grounds for filing the First Appeal were as follows :

- (i) That the State Public Information Officer did not disclose the appropriate and/or adequate information sought by the appellant under the RTI Act on 11.06.2024 and submitted on 12.06.2024.

(d) Prayer or relief sought under the First Appeal :

- (i) To provide the appropriate /proper information which are sought in the RTI application dated 11.06.2024 by the appellant.

8. Details of the order passed by the First Appellate Authority in the First Appeal u/s 19(1) of the RTI Act, 2005 dated 15.07.2024 :

Order dated 24.07.2024, being Memo No. 2260/DRSR-16/1/2023-ESTT SEC-DRSR was passed by the First Appellate Authority i.e., Addl. I.G.R. & Addl. C.S.R., W.B. & First Appellate Authority at Fortuna Tower, 9th Floor, 23A, N.S. Road, Kolkata - 700001 and the said order was received by the appellant on 27.07.2024 vide registered post.

By the said order the First Appellate directed the SPIO and R.A., Kolkata was directed to provide suitable reply to the appellant immediately as per the provisions of the RTI Act, 2005 and above guidelines as morefully mentioned in the said order which speaks itself.

9. Details of other correspondence as made by the appellant to the SPIO & R.A.,Kolkata after passing of the order by the First Appellate authority :

Inspite of receiving the said order dated 24.07.2024, being Memo No. 2260/DRSR-16/1/2023-ESTT SEC-DRSR as passed by the First Appellate Authority in the said First Appeal whereby the SPIO & R.A.,Kolkata, 5, Govt. Place (North), Kolkata – 700001 was directed to provide suitable reply to the appellant immediately as per the provisions of the RTI Act, 2005 and above guidelines as morefully mentioned in the said order, no suitable reply was issued to the appellant by the SPIO & R.A.,Kolkata.

10. Grounds for filing of this instant second appeal :

(a) That the said order passed by the First Appellate Authority and thereafter the correspondence of the appellant for compliance of the said order was duly received by the SPIO & R.A.,Kolkata and inspite of receiving the same the office of the said SPIO & R.A., Kolkata till date have not issued any reply and/or information in connection thereto to the appellant, reason of which is best known to them.
