was received from the 1st Appellant on 11/07/2024 but the 1st Appellant did not provide satisfactory answers to the information sought by the Appellant. The State Public Information Officer i.e. Deputy Commissioner of Police (Headquarters), Bidhannagar, have mentioned that a case have been lodged against Sonu Das under Section 107 Cr.pc vide Eco Park PS N.C.R no. 06/2024 dated 04/01/2024 but the State Public Information Officer i.e. Deputy Commissioner of Police(Headquarters), Bidhannagar, did not mentioned about the present status of the case.

10) *Grounds for 2<sup>ND</sup> Appeal:* As insufficient information has been received from the 1<sup>st</sup> Appellate Authority, hence as per the RTI Act'2005 it is to be construed that the 1<sup>st</sup> Appellate Authority denied providing me with the necessary information and the subsequent

appeal, this 2<sup>nd</sup> Appeal before the State Information Commission is being filed.

The Complainant prays for the grant of following relief:-

- a) That compensation be provided to the complainant for the wilful & unjustified withholding of information by the concerned State Public Information Officer & First Appellate Authority .The complainant requests that West Bengal State Information Commission to kindly decide the quantum of compensation amount.
- b) That the Appellant prays for condonation of delay if any in preferring the 2nd Appeal before this Commission.

Sub: Requesting you to direct the Officer in charge Eco Park Police Station to lodge a F.I.R. against Sonu Das, Son of late Joginder Das at Village Ghuni Uttarmath, Bonbibitala Post Office Ghuni, Police Station Eco Park Kolkata-700157 for committing cheating and criminal breach of trust.

Sir,

With due respect I, Prosenjit Ghosh, Son of Pradip Ghosh, at Village Hatiara, Post Office Hatiara, Police Station Eco park, District North 24 Parganas, Kolkata-700157 wants to state as follows:

- 1) That it is a fact that I was inducted as a licensee in respect of 2 shop rooms measuring about 56 sq.ft each situated at Village Sulanggori, J.L. no. 12 near Ram Mandir at a monthly license fees of Rs. 7,000/- ( Rupees Seven Thousand only) payable within 10th of each calendar month.
- 2) That it is true that I have also paid a sum of Rs.1,00,000/- (Rupees One Lakh only) to you as security deposit which shall be refunded back to me after the termination of the said agreement as entered by me and the accused person.
- 3) That after becoming the licensee of the said two shops I started using the same for commercial purpose. My client opened a sweets shop in the said shop rooms.
- 4) That due to nearby garage and other problems I was facing hurdles to run his business and finally finding no other alternative I was compelled to terminate the said agreement.
- 5) That as per discussion with the accused person in front of one Babu Das, his wife, and daughter the accused person committed me to refund Rs. 80,300/- (Rupees Eighty thousand three hundred only) within 30/11/2023 after deducting Rs. 14,000/- as rent and Rs. 5,700/- as Electricity charges.

6) That when the accused person failed to live up with his commitment of refunding the balance amount to the tune of Rs.80,300/- (Rupees Eighty Thousand Three hundred only) within 30/11/2023, after that I sent a representation asking the accused person to return the said balance amount within 10/12/2023.

7) That activity of the accused person of not refunding the said balance security deposit amount to the tune of Rs.80,300/- despite commitment clearly proves his illegal intention of cheating me and misappropriating the said amount for personal gain from the date of entering the said agreement with me.

8) That I also sent a legal notice through my Learned Advocate asking to refund the balance amount within 15 days, but till date no action have been taken.

9) That the accused person is very desperate and crooked in nature.

10) That I have already send a written complaint to the IC Eco Park Police Station dated 12/01/2024 vide speed post bearing EMO No. EW468096419IN on 12/01/24 which was duly received by the Authority concerned on 15/01/2024 requesting to lodge a F.I.R against the above mentioned accused person, but till date no action have been taken which is a sorry state of affair.

That under these circumstances I pray before your good office to look into this matter and direct the I.C. Eco Park Police Station to lodge a F.I.R against the accused person herein for committing cheating and criminal breach of trust.

(a) SPIO should personally join the hearing; if for a compelling reason(s) he/she is unable to be present, he/she has to give reasons for the same and shall authorise an officer not below the equivalent rank of SPIO, fully acquainted with the facts of the case **and bring complete file/file(s) with him**.

---

(b) If the SPIO attending the hearing before the Commission does not happen to be the concerned SPIO, it shall still be his/her responsibility to ensure that the SPIO(s) concerned must attend **with complete file concerning the RTI request**, the hearing along with him.

4. All the parties may submit their written submission, if any, to the Commission at least 7 days before the date of hearing. A copy of the same shall be served upon opposite party. If any party wishes to make online submission, the same may be sent to the Commission's link only viz., <https://www.wbic.wb.gov.in/online-link-paper-compliance/add>

5. SPIO is also directed to inform the third party, if any, so as to enable it to defend or present its case before the Commission. Third Party may choose to be present before the Commission either in person or through its duly authorized representative for hearing, or they may also file a written submission to the Commission before the hearing.

6. The authorised representative or the officer of the public authority and the appellant/complainant/third party is advised to carry a "proof of identity" **along with the authorization letter**.

7. Take notice that in default of your appearance on the time and date mentioned aforesaid, the case shall be heard and decided in your absence **and that there will be no adjournment and review**.

8. The parties concerned should reach the venue at least 30 minutes before the scheduled time of hearing. They are also requested to intimate their telephone/mobile numbers and email address to the undersigned.

9. The Abovenoted hearing will be held in Conference Hall 1 in the ground floor of the old Building of the West Bengal Information Commission.

10.
