

7. Grounds for Second Appeal:

- **Non-receipt of the requested information within the prescribed period.**
- **Decision of FAA unsatisfactory.**
- **Additionally, the issuance of a letter citing an incorrect section of the RTI Act, along with providing a mere two-day window for response, demonstrates a prejudiced approach on the part of the SPIO, the reasons for which are unclear. Copy of letter and our reply is attached.**

Our request was denied despite the payment of the requisite fees, citing Section 11 of the RTI Act. In our view, whenever information is required for the completion of an internal investigation by the insurance company, it cannot be completed without the necessary documents from the police authorities, who have registered the FIR and conducted the investigation. The FIR, Seizure List, statements under Section 161 CrPC, and the chargesheet (if the investigation has been completed) are public documents. However, they were denied on the grounds of Section 11 of the RTI Act.

- Kindly direct the concerned PIO to furnish the requested information immediately.
- Impose penalties under Section 20(1) of the RTI Act for the delay/failure to provide information.
- Any other appropriate relief as deemed fit.

**Subject: Objection and Protest Regarding SPIO's Denial of Information
and Appeal Decision.**

Dear Sir,

I would like to express my sincere gratitude for your response to my appeal filed under the RTI Act. However, I regret to inform you that despite your intervention, the SPIO has denied the requested information by invoking Section 11, citing third-party information. This denial was made even though the purpose for which the information was required was clearly stated.

The cases in question, New Jalpaiguri PS Case No. **1149/2023** and **Bhakti Nagar PS Case No. 1184/2013** were mentioned explicitly in the application. Despite this, the SPIO has incorrectly invoked Section 11, thereby failing to provide the information necessary for completing the internal investigation required by the insurance company to settle the matter promptly. Furthermore, in the NJP PS Case No. 1149/2023, I had clearly pointed out that the FIR was lodged 49 days after the accident, which raises serious concerns about the possibility of fraud and the conversion of a non-RTA case into an RTA case.

I had also expressed concern that if this were indeed a legitimate RTA case, a Suo moto FIR should have been lodged by the patrolling police on the day of the incident, as is customary. Unfortunately, my concerns appear to have gone unheard, and the SPIO has continued to deny the information on incorrect grounds. I am concerned that this is potentially the reason for the denial, as I have raised suspicions about fraudulent activities.

This is not an isolated incident; SPIO Siliguri has previously failed to provide information even after I submitted the requisite fees. In one instance, I had appealed to you regarding several cases of non-compliance, and I was called for a personal hearing via Memo No. 252/RTI Cell/SPC on 18/06/2024. I attended the hearing on 28/06/2024, but it turned out to be a distressing and unproductive experience, which I also brought to your attention through a formal complaint.

Due to this experience, I decided not to attend the personal hearing scheduled for 23/08/2024 regarding the current cases. I find it perplexing to be called for personal hearings by your office when SPIOs from other regions are complying with similar RTI requests without invoking Section 11 or requiring personal appearances.

While I do not wish to question your authority or privilege as a public official, I wish to express my strong objection to the arbitrary actions of the SPIO in this matter. Therefore, I respectfully inform you that I will be filing a second appeal with the Central Information Commission (CIC) and will be enclosing all relevant correspondence for their consideration.

I trust that you will understand my concerns and take the necessary steps to address this issue in the future.



First Appeal against prejudiced action of DC/ SPIO Siliguri to FAA.

Ref: Our RTI application dated 28/05/2024 in relation to Bhakatinagar PS case no 1184/2013 dated 12/06/2013.

After being completely aggrieved by a decision of SPIO Siliguri we are approaching you to intervene because you are first appellate authority in our domain. In response of our RTI letter dated 28/05/2024, we received a letter from SPIO asking some information quoting section 11 of the RTI act in our parlance. I am not going to mention and will not feel necessary to explain the third-party information condition of RTI Act, which is very clear and well explained in the Act itself. However, respecting the position of authority a reply was given explaining the reason of information sought. But they have taken decision arbitrarily and has closed the matter without providing information to us.

I only would like to let you know that the section 11 does not apply in our condition because information asked are not a confidential information. Case is registered in the PS of your Jurisdiction and insurance company would be liable as per act of MV Act in terms of paying compensation then this is mandatory for you to disclose the documents in court or in public. Police documents are available online these days on your official web then how it would relate with section 11 of RTI act in our case. I hope you can mediate in your esteemed position that quoting and misquoting of sections and provisions of the laid down laws are not taken proper in the eye of law.

Insurance Company has appointed me an investigator under the provision of their administrative law and then this is my duty to provide them information they need to decide the liability judiciously. The claim of complainant may a part of FRAUD also, so all related documents must be examined for correct decision taking.

They have closed the matter without explaining that which type of permission the need to provide such information which is asked only in the border interest of Public. If claim will not pay the interest of the complainant would prejudice and if Company decides without proper scrutiny of Police documents and other necessary documents then the chances of corrupt practices cannot be overruled. Insurance Company are paying crores & crores of rupees in settlement of claims of RTA cases, so documents are required to know that the case is filed is proper and no any element of fraud is prominent. So, documents asked from you are completely in the interest of public, so all should have been provided.

Sir, in such circumstances legal options are available for redressal of the issue, but I will flow line by line the laid down procedure as given in RTI ACT 2005. I hope issue will be solved on your intervention and we will not be forced to go for 2nd Appeal.



I hope this reply will serve your purpose for providing information asked vied out RTI letter dated 28/05/2024.




