

Subject: Second Appeal u/s 19(3) of the Right to Information Act, 2005

Sir,

I have filed an application dated 28th May, 2024 (Copy enclosed) under Section 6(1) Right To Information Act, 2005 addressed to the State Public Information Officer, Backward Classes Welfare Department, Govt. of West Bengal seeking 8 points of information regarding the promotion procedure which is admittedly undertaken by the Backward Classes Welfare Department, Govt. of West Bengal in favour of Alok Das (i.e. me) from the post of Research Investigator, CRI to Cultural Research Officer, CRI.

I received a reply (Copy enclosed) from the SPIO, Backward Classes Welfare Department vide Memo. No. BCW-16011/20/2024/DFA/ Dated: 24/06/2024. On checking the reply of the SPIO, it was found that the SPIO, Backward Classes Welfare Department had only answered my first and second points of RTI application. In query no. 2, I have asked for the file noting based on which "The Promotion Procedure in favour of Sri Alok Das, Research Investigator, CRI is under process.", instead of providing relevant file noting, the SPIO has supplied a defaced/ tampered copy of Recruitment Rule for CRO in CRI.

Here I would like to say that a clear instruction under Office Memorandum No. F.1/20/2009-IR, dated 3rd June, 2009 (Copy enclosed) has been issued by the Department of Personnel & Training, Ministry of Personnel, Public Grievances & Pensions, Govt. of India regarding disclosure of 'file noting' under RTI Act, 2005. Apart from these, Central Information Commission, High Courts and Supreme Court of India in many cases issued favourable Orders/ Judgment for providing file noting. Accordingly I have right to get 'file noting' under RTI Act, 2005.

In response to points 3 to 8 of my RTI application, the SPIO has refused to give information saying that "Regarding Query Sl. No. 3, 4, 5, 6, 7, 8:-Does not fall under the definition of "Information" under section 2(f) of the RTI Act, 2005."

This contention of the SPIO does not hold any water as Section 2(f) of RTI Act reads as "information means any material in any form, including records, documents, memos, e-mails, opinions, advices, press releases, circulars, orders, logbooks, contracts, reports, papers, samples, models, data material held in any electronic form and information relating to any private body which can be accessed by a public authority under any other law for the time being in force;" and Section 2(i) of RTI Act reads as "(i) "record" includes— (a) any document, manuscript and file; (b) any microfilm, microfiche and facsimile copy of a document; (c) any reproduction of image or images embodied in such microfilm (whether enlarged or not); and (d) any other material produced by a computer or any other device;" It is evident from the above lines that contention as expressed by the SPIO, BCWD against query at Sl. No. 3-8 has no real base and thus liable to be set aside.

As a result being felt unsatisfied with the reply of the SPIO, BCWD I have preferred for First Appeal Dated: 16th July, 2024 under Section 19(1) of the RTI Act, 2005 before the concerned First Appellate Authority & Special Secretary, Backward Classes Welfare Department.

An Order (Copy enclosed) has been received by me from the First Appellate Authority, Backward Classes Welfare Department vide No.BCW-16011/20/2024/DFA/826288 Dated 28/08/2024 in regard. The FAA has upheld the reply of the SPIO in this way "On perusal of the above, it appears that the SPIO of Backward Classes Welfare Department has duly responded to the appellant concerned by providing reply vide Letter No. BCW- 16011/20/2024/DFA dated 24.06.2024 while stating that the promotion procedure in favour of Sri Alok Das, Research Investigator, CRI is still under process. Also the SPIO, Backward Classes Welfare Department has rightly informed the petitioner that his queries Sl. No. 3 to 8 do not fall under the definitions of "information" u/s 2(f) of the RTI Act, 2005." The inference drawn by the First Appellate Authority is a clear case of failing to apply proper consideration.

PRAYER

Under these circumstances as stated above, I humbly pray before the West Bengal Information Commission to instruct the SPIO, BCWD to provide complete and correct information covering all points (Sl. No. 1-8) as prayed through my RTI Application dated 28th May, 2024 without any further delay.

Since this petition involves service and recruitment issues i.e. promotion related issues, I am requesting the honourable West Bengal Information Commission to hear this petition as soon as it is possible.

Madam,

I have filed a RTI application dated 28.06.2024 (copy enclosed) addressed to the SPIO, BCWD. I have received a response from the SPIO, BCWD vide Memo. No. BCW-16011/20/2024/DFA/ Dated: 24/06/2024, (copy enclosed with enclosures) delivered to my postal address on 01.07.2024 by India Post. The SPIO, BCWD has failed to provide complete and correct information as sought by me rather she has provided defaced/tampered information. As a result of which being felt aggrieved, I am filing the present appeal.

In my RTI application, I have asked for 8 counts of information, these were marked serially number at 1 to 8 in my RTI application. The SPIO, BCWD has given response only for query no. 1 and 2. For convenience of discussion the query no. 1 and 2 and responses as it is received from the SPIO are furnished below:

My queries: "1) What is the current status of that 'Promotion Procedure' as on date of your reply as mentioned above? 2) Kindly provide a copy of the file noting based on which "The Promotion Procedure in favour of Sri Alok Das, Research Investigator, CRI is under process.""

Reply of the SPIO, BCWD: "Regarding Query Sl. No. 1 and 2: The Promotion Procedure in favour of Sri Alok Das, Research Investigator, CRI is still under process. Actually, the relevant promotion procedure has been laid down in erstwhile Scheduled Castes and Tribes Welfare department's notification no. 4952-T.W. dated: 08.09.1979 (Copy enclosed) and the promotion process is under progress."

My contention: It is evident from the above lines that in query no. 2, I have asked for the file noting based on which "The Promotion Procedure in favour of Sri Alok Das, Research Investigator, CRI is under process.",

instead of providing relevant file noting she has supplied a defaced/ tampered copy of Recruitment Rule for CRO in CRI. An examination of the supplied Recruitment Rule for CRO in CRI has revealed that defacement/ tampering has been done against Paragraph 2 of Sub-rule (1) of Rule (A) by splashing black ink over the said clause, make it illegible, which actually reads as: "Provided that not more than 50 per cent of the posts shall be filled up by promotion." Here it is worth mentioning that the above mentioned provision of the said recruitment rule is an obligatory provision of the Recruitment Rule. Moreover, Recruitment Rule for CRO in CRI is framed under Article 309 of the Constitution of India. One cannot change or modify a Recruitment Rule framed under Article 309 of the Constitution of India in this way by splashing black ink on it. If anybody does so, such act should be considered as wilful concealment of fact by providing misleading information. In this regard I would like to inform you that a fair legible copy of Recruitment Rule is already available with me, copy of which is enclosed herewith for your perusal. Here it is needless to say that in my RTI application in query no. 2, I have not even asked for the Recruitment Rule for CRO in CRI, what I have asked for is a copy of the file noting based on which "The Promotion Procedure in favour of Sri Alok Das, Research Investigator, CRI is under process." Section 2 (f) of the RTI Act defines 'information' which includes 'record'. Section 2(i) (a) states that a 'record' includes any document, manuscript and file. File notings are integral part of a file. In CIC Decision No. ICPB/A-1/CIC/2006 dt.31.01.2006, the Central Information Commission held that file notings are not, as a matter of law, exempt from disclosure. Thus, file notings can be disclosed under the Act.

For queries positioned at Sl. No. 3-8 in my RTI application: The SPIO, BCWD has denied to provide any information, according to her, "Regarding Query Sl. No. 3, 4, 5,6,7,8:-Does not fall under the definition of "Information" under section 2(f) of the RTI Act, 2005." This contention of the SPIO does not hold any water as Section 2(f) of RTI Act reads as "information means any material in any form, including records, documents, memos, e-mails, opinions, advices, press releases, circulars, orders, logbooks, contracts, reports, papers, samples, models, data material held in any electronic form and information relating to any private body which can be accessed by a public authority under any other law for the time being in force;" and Section 2(i) of RTI Act reads as "(i) "record" includes— (a) any document, manuscript and file; (b) any microfilm, microfiche and facsimile copy of a document; (c) any reproduction of image or images embodied in such microfilm (whether enlarged or not); and (d) any other material produced by a computer or any other device;" It is evident from the above
