## Facts on records

The matter was last heard on 24.11.2020 and necessary order was passed by the Commission. The same was communicated to the concerned authority on 28.01.2021. After receipt of the order, the SPIO vide letter dated 01.03.2021 submitted an action taken report before the Commission, which does not contain the requested information.

In order to dispose of the matter, the Commission has fixed further hearing on 06.08.2021. Accordingly, the hearing is held today on 06.08.2021.

## Decision:

On being asked as to why the last order of the Commission has not been complied with, the SPIO submits that the information is lying with another Branch of the Public Authority and for obtaining the same, the RTI petition has been transferred under Section 6(3) of the RTI Act, 2005 to the concerned SPIO (HQ) and Deputy Secretary (Academic) of WBCHSE vide letter dated 01.03.2021.

After due consideration of all facts and submission, the Commission hereby declared the SPIO (HQ) and Deputy Secretary (Academic), WBCHSE as deemed SPIO in the present case and directs him to provide the information to the Appellant after obtaining the same from the concerned authority within a period of 3 (three) weeks from the date of receipt of this order under intimation to the Commission.

Next hearing will be held online. The date and time of the next hearing will be intimated in due course. The present SPIO and the SPIO (HQ) and Deputy Secretary (Academic), West Bengal Council of Higher Secondary Education are directed to attend the next hearing along with the action taken report. The present SPIO is further directed to serve a copy of this order to the SPIO (HQ) and Deputy Secretary (Academic), West Bengal Council of Higher Secondary Education for compliance.

- 6. The Commission, after discussion and deliberation, observed that the appellant has been replied adequately vide para 4 above. The case is closed.





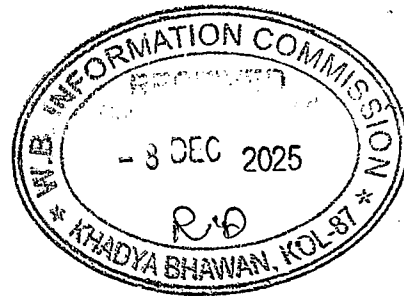

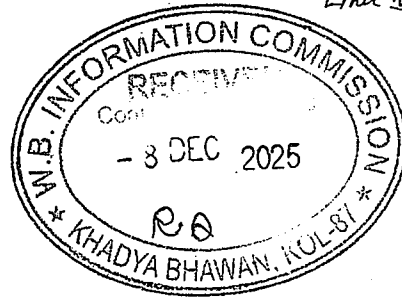
