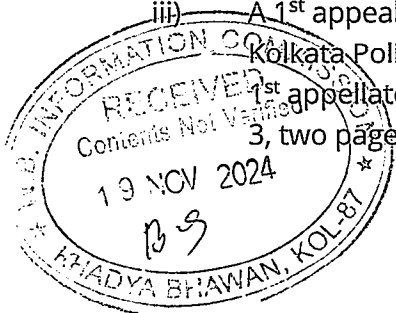
Ref: 1) My application for information U/S 7(1) of the R.T.I Act, 2005 dt.16.09.2024 addressed to the O.C Survey Park P.S. since the information sought (part or whole) was held by Survey Park P.S. 2) My 1st appeal dt.28.09.2024 addressed to the Commissioner of Kolkata Police and also forwarded to the D.C.P & 1st appellate authority (East div.), Kolkata Police.

Sir/ Madam,


The undersigned, being a Group-A Government Officer & public servant [U/S 2(28) of B.N.S] hereby submits an appeal application with the following details as per prescribed rules.

- Appeal is being raised against:** (i) Proloy Bhattacharjee (O.C Survey park PS as on 18.09.2024), (ii) Arish Bilal (D.C.P & 1st appellate authority, East div. Kolkata Police as on 29.10.2024) & (iii) Asst. Commissioner (I) & S.P.I.O, East div. Kolkata Police, as on 29.10.2024.
- Particulars of order dt. 19.10.2024 & 29.10.2024:** In both the orders, Arish Bilal (D.C.P & 1st appellate authority, East div. Kolkata Police as on 29.10.2024) has not only rejected my appeal, but also refused to accept my application as R.T.I application.
- Brief facts leading to appeal:**
 - An R.T.I application U/S 7(1) of the R.T.I Act, 2005, dt.16.09.2024 along with two attachments and a bank cheque (Annexure-1, five pages) was sent to Proloy Bhattacharjee (O.C Survey park PS), since the information sought has been held by his office. The same was received by him on 18.09.2024 (Annexure-2).
 - Proloy Bhattacharjee (O.C Survey park PS), driven by mala fide intentions & constituting criminal motives, confined & restricted the R.T.I application in his office and did not forward the same to the concerned S.P.I.O at all, thus violating sections 6(3) & 7(1) of the R.T.I Act, 2005.
 - A 1st appeal dt.28.09.2024 addressed to Manoj Kr. Verma (Commissioner, Kolkata Police) was mailed to the addressee and also to Arish Bilal (D.C.P & 1st appellate authority, East div. Kolkata Police as on 28.09.2024) (Annexure-3, two pages). The hard copy of the same was received by the addressee on



30.09.2024 (Annexure-4). Following that, neither Manoj Kr. Verma (Commissioner, Kolkata Police) sent any forwarding letter to the applicant stating the transfer of the 1st appeal to Arish Bilal (D.C.P & 1st appellate authority, East div. Kolkata Police as on 28.09.2024), nor did Arish Bilal (D.C.P & 1st appellate authority, East div. Kolkata Police as on 28.09.2024) send any final decision/order of acceptance/rejection of the 1st appeal to the applicant until 17.10.2024.

- iv) On 17.10.2024, a legal notice regarding this fiasco was served to Ajoy Prasad [Jt. C.P(O), Kolkata Police] (Annexure-5) and the same was also forwarded to the Chairman, NCSC. The Chairman, NCSC, took cognizance of the facts & circumstances and forwarded the matter to the regional office, NCSC on 18.10.2024 (Annexure-6).
- v) As a consequence, Arish Bilal (D.C.P & 1st appellate authority, East div. Kolkata Police) sent an email with an attachment to the applicant on 19.10.2024, which stated that not only his 1st appeal has been rejected but also his application has not been treated as R.T.I application (Annexure-7, three pages).
- vi) A complaint email was sent to the Chairman, NCSC and to the regional office, NCSC on 19.10.2024 (Annexure-8).
- vii) On 20.10.2024, the Chairman, NCSC again took cognizance of the facts & circumstances and forwarded the matter to the regional office, NCSC (Annexure-9).
- viii) On 22.10.2024, the hardcopy of the order of 1st appeal with Memo No: ED/1-2601/RTI dt.19.10.2024 was received by the applicant (Annexure-10, two pages).
- ix) On 01.11.2024, another order of 1st appeal with Memo No: ED/1-2880/RTI dt.29.10.2024 was received by the applicant (Annexure-11, two pages).
- x) On 11.11.2024, two backdated forwarding letters, one with Memo No. 17062/RPT+RTI (01.10.2024) from the Addl. C.P(III) & Appellate Authority (RTI) Kolkata Police (Annexure-12) and another with Memo No. 17916/RPT+RTI (23.10.2024) from the Commissioner, Kolkata Police (Annexure-13) was received by the applicant. These two letters were sent with sole intention to mislead the applicant, along with ulterior motives to cover up the criminal activities of Manoj Kr. Verma (Commissioner, Kolkata Police), Ajoy Prasad [Jt. C.P(O), Kolkata Police], Proloy Bhattacharjee (O.C Survey park PS) and Arish Bilal (D.C.P & 1st appellate authority, East div. Kolkata Police).
- xi) The Asst. Commissioner (I) & S.P.I.O, East div. Kolkata Police (as on 29.10.2024), although taking belated cognizance of the matter even after getting two forwarded letters from Arish Bilal (D.C.P & 1st appellate authority, East div. Kolkata Police), didn't take any initiative to redress this issue at all.

4. Appeal grounds for the relief:

- i) Both Proloy Bhattacharjee (O.C Survey park PS) & Arish Bilal (D.C.P & 1st appellate authority, East div. Kolkata Police) are habitual criminal offenders since substantive evidences have already been recorded confirming their

crimes constituted with ulterior motives to satiate their personal vendetta against the applicant.

- ii) Proloy Bhattacharjee (O.C Survey park PS) [in contrivance with Rupanjali Roy alias Rupanjali Roy Das (D/O Lt. Balai Roy, of 1 no. Daulatpur, Kolkata-700140) & other criminal offenders of Maheshtala PS and Diamond Harbour Police District] has intentionally suppressed the R.T.I application, confined it within his office and prevented it from forwarding to the concerned S.P.I.O [Asst. C.P (I), East div.] since answering the enquiries made in the R.T.I application would have definitely revealed the facts of cognizable & non-cognizable crimes constituted by Rupanjali Roy alias Rupanjali Roy Das (D/O Lt. Balai Roy, of 1 no. Daulatpur, Kolkata-700140) & other criminal offenders of Maheshtala PS and Diamond Harbour Police District, against the applicant.
- iii) Arish Bilal (D.C.P & 1st appellate authority, East div. Kolkata Police) didn't bother to reply to the 1st appeal sent to him on 28.09.2024 until serving the legal notice to Ajoy Prasad [Jt. C.P(O), Kolkata Police] on 17.10.2024, which testifies his wilful gross negligence of duty accompanied by criminal conspiracy with intentions to cause harm to the applicant.
- iv) Arish Bilal (D.C.P & 1st appellate authority, East div. Kolkata Police) in his decision of the 1st appeal, has fabricated and misrepresented the "West Bengal R.T.I Rules, 2006" [original information about the same has been already provided in the letter dt.17.08.2022, sent by the Jt. C.P (O), Kolkata Police (Annexure-14)], making & claiming his declaration as true despite knowing it to be false, by creating lame excuses stating that payment by cheque issued to the Commissioner of Kolkata Police and R.T.I application submitted to O.C Survey Park PS to be unlawful as per West Bengal R.T.I Rules, 2006. His sole intention was to reject the 1st appeal, with motives to obscure the criminal offences of Proloy Bhattacharjee (O.C Survey park PS), Rupanjali Roy alias Rupanjali Roy Das (D/O Lt. Balai Roy, of 1 no. Daulatpur, Kolkata-700140) & other criminal offenders of Maheshtala PS and Diamond Harbour Police District.
- v) There are substantive evidences testifying confirmation & acceptance of payments of R.T.I applications done by cheques issued to the Commissioner of Kolkata Police, as per the "West Bengal R.T.I Rules, 2006" (Annexures-15, 16) and R.T.I applications of the applicant has been forwarded to the O.C Survey park PS U/S 6(3) of the R.T.I Act, 2005, since information sought had been held with the same office (Annexure-17, 18). There is also substantive evidence testifying the written approval of Arish Bilal (D.C.P & 1st appellate authority, East div. Kolkata Police) to acceptance of R.T.I applications done by payments through cheques issued to the Commissioner of Kolkata Police, as per the "West Bengal R.T.I Rules, 2006" (Annexure-19, two pages). Even the S.P.I.O of Diamond Harbour Police District has accepted the payment by cheque for R.T.I application dt.18.08.2024 and provided information to the applicant, which strongly testifies the fact that payment for R.T.I application through cheque is at par with extant amendments of the West Bengal R.T.I Rules, 2006 (Annexure-20, six pages).

5. Relief sought:

- i) Specific, complete and appropriate answers to all the enquiries made in the R.T.I application, supported by certified copies of documents (if any).
- ii) Punitive, coercive & disciplinary actions against Proloy Bhattacharjee (O.C Survey Park PS), Arish Bilal (D.C.P & 1st appellate authority, East div. Kolkata Police), Asst. Commissioner (I) & S.P.I.O, East div. Kolkata Police (as on 29.10.2024), Manoj Kr. Verma (Commissioner, Kolkata Police) and Ajoy Prasad [Jt. C.P(O), Kolkata Police] under their applicable service rules [U/S 20(2) of R.T.I Act, 2005], U/S 61(1), 61(2), 198, 199, 210, 211, 229, 234, 237, 239 of B.N.S & U/S13B of the Calcutta Police Act.
- iii) Since Proloy Bhattacharjee (O.C Survey Park PS), Arish Bilal (D.C.P & 1st appellate authority, East div. Kolkata Police), Asst. Commissioner (I) & S.P.I.O, East div. Kolkata Police (as on 29.10.2024), Manoj Kr. Verma (Commissioner, Kolkata Police) and Ajoy Prasad [Jt. C.P(O), Kolkata Police], with mala fide intentions & criminal motives, denied the request of information and also obstructed (by criminal manner) in furnishing the information, the Commission should lawfully [U/S 20(1) of R.T.I Act, 2005] impose on each of them, a penalty of two hundred and fifty rupees (Rs.250/-) each day till application information is furnished.

6. **Verification by the applicant:** I attest that all the information provided herein, are true to the best of my knowledge. My identity & address proof (copy of Aadhaar card verified by DigiLocker) has also been attached herewith (Annexure-21).
