Also evident is the joining report of the applicant submitted before the Officer-in-Charge, Gariahat Fire Station which is dated 17.01.1989.

Mr. Mondal, learned advocate for the State respondent also agrees that the date of joining as prayed for 17.01.1989 is correct and this anomaly is being corrected by the office of the respondent. 

The prayer in this application is for a direction to the respondents to correct the applicant's date of joining in service as 17.01.1989 instead of 20.12.2001 and correct the same for his seniority in the gradation list. The applicant had joined the service as a Cleaner-cum-Attendant (CCA) under Fire and Emergency Services Department on 17.01.1989. Submission of Mr. Banerjee is that the above fact of his joining on 17.01.1989 is evident from page 12 of this application in which the order dated 16.01.1989 confirms the applicant, Ajit Kumar Porey being appointed in this post. Also evident is the joining report of the applicant submitted before the Officer-in-Charge, Gariahat Fire Station which is dated 17.01.1989.

Mr. Mondal, learned advocate for the State respondent also agrees that the date of joining as prayed for 17.01.1989 is correct and this anomaly is being corrected by the office of the respondent. Further, the pension papers submitted to the office of the Principal Accountant General (A&E), West Bengal also bears the same date of joining on 17.01.1989. He also assures such rectification in other documents will be done at the earliest.

In view of the above submissions, this application is disposed of with a direction to the respondent authority to rectify the date of joining in the relevant documents during the service life of the applicant and consequential benefits, if any, to be disbursed accordingly.

- \* Promoted to the post of Muharrir Gr-II vide E.O. No.-595/18, dated: 11/05/2018
- \* Promoted to the post of Muharrir Gr-I vide E.O. No.-246/22, dated: 30/12/2022

He got his Career Advance Scheme Benefits like 8 years, 16 years and 25 years benefits by counting his entry into the service i.e. from 17-01-1989. His CAS benefits are as follows:

- \* Allowed 8 years CAS benefit with effect from 01/01/2003
- \* Allowed 16 years CAS benefit with effect from 01/07/2006
- \* Allowed 25 years CAS benefit with effect from 01/07/2014
