Sub - Appeal against reply given by SPIO under RTI Act 2005

Sir,

1. Under the provision of section 6 of RTI Act 2005 I applied to SPIO & Special Land Acquisition Officer, Haldia vide my application dated 18-07-2024 (copy enclosed) requesting him to provide me information in relation with payment of pending compensation amount. The SPIO vide his memo No 1222/LA(H) dated 05-08-2024 (copy enclosed) directed me to apply to his office itself to enable him to arrange payment of the compensation whatsoever.

2. Accordingly, I applied him vide my application dated 20-08-2024 (copy enclosed) requesting for payment of compensation amount. Since then a number of times I have contacted his office staff about status of payment. Every time I have been informed saying the case has been forwarded to State Govt office at Nabanna for approval and fund arrangement. Seeing abnormal delay in the matter I, under RTI - 2005 again applied to Special Land Acquisition Officer & SPIO vide my application dated 04-06-2025 (copy enclosed) seeking some information.

3. The reply of SPIO vide his memo No 852/LA(H) dated 18-06-2025 (copy enclosed) violates the provision and is not acceptable to me.

4. Any Indian citizen has the right to get any information from the competent authority if it is otherwise not exempted from disclosure as per section 8 of the Act. My query is within the purview of section 2 and not covered under section 8 of the Act. The instant reply of the SPIO has indicated towards his expression of insolence.

5. Under the provision of section 19 of the Act I, being aggrieved do hereby appeal and request your honour to kindly review the reply of the SPIO and provide me the information sought for through my application dated 04-06-2025 at the earliest and oblige.
