Being aggrieved and dissatisfied with the in action on the part of the State Public Information Officer (SPIO) as well as the First Appellate Authority thereby supplying the information as sought for under section 6 of the Right to Information Act, 2005 by the applicant/appellant herein, your appellant prefers this second appeal under section 19(3) of the Right to Information Act, 2005 on the following grounds :-

GROUND

- I. For that the SPIO as well as the First Appellate Authority has failed to supply the information the information whether any call letter was issued in the name of the applicant for interview for the post of Laboratory Attendant by the Principal,

Mahadevananda Mahavidyalaya, Monirampore, Barrackpore, North 24-Parganas as a member of land loser family as per name sponsored by the office of the Director of Employment, SE(EC) ECLL, West Bengal.

- II. For that the State Public Information Officer as the First Appellate Authority has failed to supply if any such call letter was sent to the applicant/appellant what are the particulars of call letter namely letter number, date etc. and in what manner such call letter was sent to the applicant/appellant.
- III. For that the State Public Information Officer as the First Appellate Authority has failed to supply the information whether such call letter was received by the applicant/appellant and what was the date of such receipt. If such call was received by the applicant/appellant, the receipt of such call letter may be furnished with the reply.
- IV. For that the State Public Information Officer as the First Appellate Authority has failed to supply the information whether the office of the Mahadevananda Mahavidyalaya, Monirampore, Barrackpore, North 24-Parganas, received the letter under Order No. EC/LB/N-24-Pgs/90/16/5134A dated 23.09.2016 issued by the Director of Employment SC (EC) ECLL, West Bengal, if yes, kindly supply the date of receipt of the said order.
- V. For that the SPIO mechanically and without application of mind dispose of the application of the applicant only on the ground that the application is incomplete, which is illegal and not sustainable in the eye of law.

- VI. For that the First Appellate Authority as well as the SPIO has failed to supply the information as sought for by the appellant as per the provision of the Right to Information Act, 2005, which is illegal and arbitrary.
- VII. For that the First Appellate Authority as well as the SPIO has failed and/or neglected to discharge his duty as per the provision enumerated in the Right to Information Act, 2005 thereby furnishing information as sought for by the appellant, which is not sustainable in the eye of law.
- VIII. For that the acts and actions on the part of the SPIO as well as the First Appellate Authority, for not supplying any information as sought for by the applicant/appellant herein, is illegal and not sustainable in the eye of law.
