Facts on Record :

1. Shri Milanendu Bikash Laha [ hereinafter referred to as the appellant ], vide his application dated- 18.09.2024 requested for the following information from SPIO, South Dum Dum Municipality:-
  - i) A copy of the report of ultrasonography [ USG ] of whole abdomen of MITA LAHA (my wife) 52 years which was done on 01.03.2023 at South Dum Dum Municipal Hospital under Dr. Dipak Das, Consultant Sonologist. The original report is lost.
2. SPIO, South Dum Dum Municipality sent a reply to the appellant vide memo no. SDM/2420/XXIV dated 22.11.2024 stating that " as reported by the medical officer of this office, duplicate report (investigation) can be given to the respective person on production of original bill of the said report."
3. Grounds for 2<sup>nd</sup> appeal is dissatisfaction with the reply of the SPIO.

Decision and Deliberation :

4. The appellant was present in person and the SPIO was present virtually.
5. The Commission observed that the appellant has been replied, vide para 2 above. The SPIO submitted that the appellant has been seeking a USG Report of his wife but it is a personal information exempted u/s 8 (1) (j) RTI Act. It came out during discussion that the appellant has a dispute with his wife and his wife has been staying at her father's house.
6. The Commission observed that the information sought by the appellant is a personal information and is exempted u/s 8 (1) (j) RTI Act and Section 44 (3) Digital Personal Data Protection Act, 2023. So, it need not be given. The case is closed.
