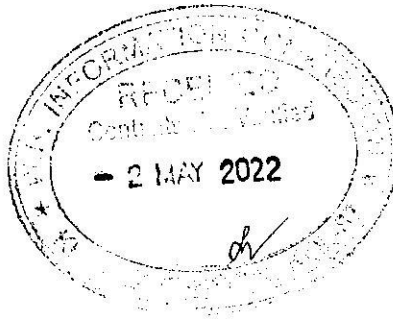

Sir,

This to inform you that a I filed an online RTI letter U\S 6(1) to the Dist.Registrar of Purbo Bardhman on 01/05/2021 rearding a muslim marriage certificate. This letter has been forwarded to Dist.Registrar Paschim Burdwan .in connection with that letter the D.R of Paschim Burdman wanted from me a copy of that marriage certificate .I sent the same on 06.7.2021 .He replied vide his memo no-552 dt 27.9.2021 and informed me *that there is no official record of my marriage.* it means that he went through the register volume ii of 2001 page NO.151. Again I wanted to inspect the said register u/ 2(j) of RTI act the DR of Paschim Burdwan replied me by his memo 621 dt 1/11/2021 DT.1/11/2021. *that there is ' No record available ' in the office for verification of your marriage certificate* so the inspection of same does not arise . The District Registrar purba burdwan replied against my RTI letter dated 29.11.2021 that the *register of a M.M.R is kept in the custody of the Muslim marriage Registrar of that P.S area* as per his letter memo:470/DR/RTI/01 DT.8.12.2021. I filed an RTI to the Muslim Marriage Registrar, KANKSA PANAGARH on 8\12\2021 the present muslim marriage registrar ,kanksa , panagarh replied to me on 9.12.21 that he has no knowledge about this marriage. And he also replied to D.R Paschim Burdwan on 12/8/2021 that he has no such a register and he has been not handed over the said register from the previous KAZI or his son. But he mentioned the name of Md. SHAFIQUE who himself called the Kazi and Registrar. (copy attached). I filed first appeal to the Appellate Authority after the discussion on 17.12.2021 he sent me the order copy, memo no 3649/DRSR-16/4/2021/ESTT-SEC-DRSR dt.30.12.2021. on which he *directed to D.R. Purbo Burdwan for taking necessary*

action so that the appellant can get his accessible information as per RTI Act 2005. Till date I got no information.

I being aggrieved file this 2nd appeal to you as they supplied me the unsatisfactory, misleading, incomplete and incorrect information and did not issue the attested certified copy of that marriage certificate which was issued to Dilnawaz tabassum by the MMR& kazi Abdus Salam and the key player Md.Shafique of kanksa,panagarh.

I therefore request your kind honour to take necessary action under section of RTI act 2005 for the sake of transparency and to stop the ill practice.

I, SAIFUL ISLAM s/o late Anwarul Islam aged 48 being Indian citizen do hereby solemnly that the statements made herein are true to my knowledge based on record and the rest are my submissions to the Hon,ble West Bengal information Commission.

6. Please let me know is this marriage solemnized in presence of kazi ,wakil and witnesses if yes then what is the time and place of nikha/marriage.
7. Please let me know did Dilnawaz tabassum show any document to register her marriage if yes supply me the document if not then why and how this marriage has been registered.
8. Please provide me the certified copy of this marriage registration certificate as per original register.

9. What is the criteria to register marriage? Let me know whether the criteria have been maintained for the above said marriage?

10. Please provide me the number of registered marriage from 1st march 2001 to 31 Dec 2001 without L.T.I of groom and witnesses.

Please provide me all information regarding the same as I mentioned above.

Kindly provide me the details along with all the information, under RTI Act 2005.

As per section 6(3) of the RTI Act 2005, In case, the requested information is held by another public authority, I request the PIO to transfer the application or part of it within FIVE days and immediately inform me about such transfer.

As per section 7(8)(iii) and 7(3)(ii) of the RTI Act 2005 I request the PIO to Inform me of the particulars of First Appellate Authority.

The appeal dated 04.10.2021 has been filed on 07.10.2021 by Mr. Saiful Islam before the First Appellate Authority u/s 19(1) of the RTI Act, 2005 being aggrieved by the reply of District Registrar, Paschim Burdwan.

In reply to the application dated 01.05.2021 under sec (6) of the RTI Act, 2005 submitted before SPIO & District Registrar, Purba Burdwan by the applicant Mr. Saiful Islam the concerned SPIO has transferred the petition vide M.No. 232/DR/ADMIN/ESTT/1 dated 21.06.2021 to the SPIO & District Registrar Paschim Burdwan as the case is related to the MMR & Kazi under Kanksa P.S. of Paschim Burdwan. The SPIO & District Registrar, Paschim Burdwan made an inspection for obtaining report from Sk. Hasibul, present MMR under Kanksa P.S. and Sk. Rezaul Karim, son of Late Abdus Salam the then MMR of Kanksa P.S., but he failed to get any official record from them and after all he was unable to supply any information in this regard for want of official record.

In reply to his appeal case no. 21/2021 the notice for hearing was issued vide M.No. 3181/DRSR-16/4/2021 ESTT SEC-DRSR dated 25.11.2021, both the appellant and the respondent were duly present on 17.12.2021 and submitted their written statement. The appellant claimed in his statement that the copy of marriage certificate which was shown to lodge criminal case u/s 498A was fully fake and false and he never married with Dilnawaz Tabasum at any date at any place. So he needs to get record of the said marriage from original register of MMR & Kazi, under Kanksa P.S.

However, as the marriage as claimed registered on 30.12.2001 and the district of Paschim Burdwan was formed in the year 2018, the case record of the said marriage should lie under the District Registrar, Purba Burdwan the then undivided district of Burdwan. So the SPIO & District Registrar, Purba Burdwan is directed for taking necessary action so that the appellant can get his accessible information as per RTI Act, 2005.

With the above direction, the appeal stands disposed of.

However, if aggrieved, the party concerned may prefer second appeal before the State Chief Information Commissioner, West Bengal, Khadya Bhawan, 11A, Mirza Ghalib Street, Kolkata – 700087.
