3. The SPIO informed the Commission that no such record of filing RTI application by the appellant exists in their office. The SPIO was advised to download



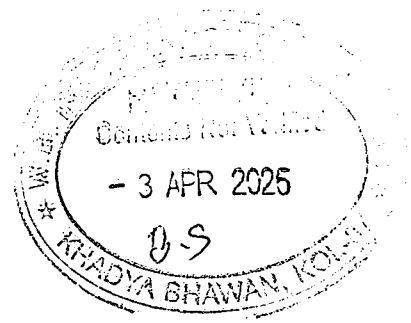
