(3) Reason for sending notice to the respondent for hearing in three different cases in two different Courts by overlooking the fact that same points and same events have been used and also by overlooking Article 20(2) of the Indian Constitution.

BACKGROUND:

Case numbers: (1) ACGR 5166 OF 2016 (FIR NO. 319 OF 2016) DATED 01.09.2016, 2ND JM, ALIPORE, (2) DV AC-272 OF 2017 DATED 27.01.2017, 2ND JM, ALIPORE, (3) AC M-83 OF 2021, DATED 27.01.2021, IST JM, ALIPORE, UNDER THE JUDGESHIP OF THE HONOURABLE LD. DISTRICT and SESSIONS JUDGE, ALIPORE, SOUTH 24 PARGANAS, WEST BENGAL.

I have won the ex-parte decree of divorce against my ex-wife on 24.04.2017 based on cruelty & desertion under section 13(1)(ia)(ib) vide order no. MAT SUITE 248 of 2016.

Period to which the information relates: 2016 - 2022.

In the light of the above mentioned background, please provide the following information under section 2(f) and 2(j) of the RTI Act:

(A) Reason for overlooking the MAT SUITE Order No. 248 of 2016 by this Honourable LD. Court.

- (B) The petitioner has used the same points and the same events in the ACGR-5166 of 2016 (FIR No. 319 of 2016) dated 01.09.2016 (2nd JM) and in the DV AC-272 of 2017 dated 27.01.2017 (2nd JM) and in the AC M-83 of 2021 dated 27.01.2021 (Ist JM). The reason for accepting such applications by this Honourable LD. Courts where there is a violation of Article 20(2) of the Indian Constitution.
- (C) The reason for sending notice for hearing in two different Courts in three different cases based on the same points and the same events without providing a single evidence to date.
- (D) The reason for overlooking the last sentence of the Paragraph 22 in the Cr.P.C. 125 application where the petitioner has stated that "she till now wants to stay with the Opposite Party wherever he wants to stay" which proves that the petitioner has willfully and deliberately deserted the respondent without any valid reason.
- (E) The reason for overlooking the FIR against the petitioner and her parental relatives being FIR No. 82 of 2020 dated 11.02.2020 Under Sections 341/323/427/506/34 of the I.P.C. and then the Police upon the conclusion of the investigation has submitted a Charge Sheet Under Sections 448/323/506/34 of the I.P.C.
- (F) Reason for overlooking the police complaints against the petitioner and her parental relatives in different Police Stations 08.04.2016 at the Nimta P.S., 12.05.2016 at the Nimta P.S., 14.05.2016 at the Nimta P.S., GDE No. 700 of 2016., 02.06.2016 at the Thakurpukur P.S., 11.06.2016 at the Balasore Town P.S., SD No. 259, 260, 261, 263 and 264, 12.06.2016 at the Nimta P.S., GDE No. 614 of 2016., 12.06.2016 the Medical Examination of Shri Abhijit Palit was conducted by a Government Doctor at the North Dum Dum Municipal Hospital under the purview of the then Sub-inspector of the Nimta P.S., 6394 of 2016., 12.08.2016 at the Nimta P.S., 20.08.2016 at the Thakurpukur P.S.
- (G) The Honourable LD. Courts have completely overlooked the fact that the respondent (Shri Abhijit Palit) is legally married to Mrs. Lipika Palit since 4th May 2018. The petitioner has been deliberately and intentionally claiming to be the legally married wife of the respondent everywhere which is an Abuse of the Process of Law. The reason for the LD. Courts being silent in this matter is not known to the respondent.

- (H) The reasons as per the records for not referring the two notable judgements in my case related to the ACGR 5166 of 2016 (1) Anju vs Govt. Of Nct Of Delhi & Ors.; on 4 February, 2019, CRL. REV. P. 730/2016 & (2) Alok Lodhi & Ors. Vs. State of MP & Anr., MCRC 47904 of 2019.
- (I) The then I.O. of the Thakurpukur P.S. named LSI BABY HAZRA during the Cr.P.C. 41A interrogation in the ACGR-5166 of 2016 (FIR No. 319 of 2016) told Shri Ashoke Kumar Palit (respondent's father) that "As your son have filed divorce petition so Nivedita Palit nee.......Roy have filed 498A". The reason for accepting such an application by the LD. Court where the application is based on revenge and which is after thought is not known to the respondent and his parents. The petitioner's ex-matrimonial house is at Nimta which falls under the jurisdiction of the Honourable LD. District and Sessions Judge, Barasat, North 24 Parganas. If the incidents were genuine, the petitioner could have easily filed 498A at the Barasat Court but she filed 498A not only after receiving the divorce petition summon but also at the Alipore Court, South 24 Parganas which have a territorial jurisdiction.

Copy of the E-TICKET from Balasore to Ongole dated 03.06.2016 and from Ongole to Balasore as mentioned by the petitioner in paragraph-15 in the AC-272 of 2017 dated 27.01.2017 and in paragraph-16 in the FIR No. 319 of 2016 (ACGR 5166 of 2016) dated 01.09.2016 and in paragraph-15 in the AC M-83 of 2021 dated 27.01.2021.
- 3. Copies of all the medical reports of injury of Mrs. Nibha Roy (mother of the petitioner), Miss Nandita Roy (younger sister of the petitioner) and Nivedita Palit nee.....Roy (petitioner) as mentioned by the petitioner in paragraph-15 in the AC-272 of 2017 dated 27.01.2017 and in paragraph-16 in the FIR No. 319 of 2016 (ACGR 5166 of 2016) dated 01.09.2016 and in paragraph-15 in the AC M-83 of 2021 dated 27.01.2021.
- 4. Copies of all the medical reports of injury based on the alleged physical assault

as mentioned by the petitioner in paragraph-6 in the AC-272 of 2017 dated 27.01.2017 and in paragraph-7 in the FIR No. 319 of 2016 (ACGR 5166 of 2016) dated 01.09.2016 and in paragraph-6 in the AC M-83 of 2021 dated 27.01.2021.

- 5. The exact date/time/place/year of the alleged sexual assault as mentioned by the petitioner in paragraph-7 in the AC-272 of 2017 dated 27.01.2017 and in paragraph-8 in the FIR No. 319 of 2016 (ACGR 5166 of 2016) dated 01.09.2016 and in paragraph-7 in the AC M-83 of 2021 dated 27.01.2021.
- 6. Copies of all the medical reports of injury based on the alleged physical assault as mentioned by the petitioner in paragraph-9 in the AC-272 of 2017 dated 27.01.2017 and in paragraph-10 in the FIR No. 319 of 2016 (ACGR 5166 of 2016) dated 01.09.2016 and in paragraph-9 in the AC M-83 of 2021 dated 27.01.2021.
- 7. The exact date/time/place/year of the alleged sexual assault as mentioned by the petitioner in paragraph-11 in the AC-272 of 2017 dated 27.01.2017 and in paragraph-12 in the FIR No. 319 of 2016 (ACGR 5166 of 2016) dated 01.09.2016 and in paragraph-11 in the AC M-83 of 2021 dated 27.01.2021.
- 8. The exact date/time/place/year of the alleged sexual assault as mentioned by the petitioner in paragraph-13 in the AC-272 of 2017 dated 27.01.2017 and in paragraph-14 in the FIR No. 319 of 2016 (ACGR 5166 of 2016) dated 01.09.2016 and in paragraph-13 in the AC M-83 of 2021 dated 27.01.2021. The petitioner has also alleged of sexual abuse on one day early May 2016. The respondent wishes to know that exact date.
- 9. Copies of all the medical reports of the child (Anish Kumar Palit) including the vaccination details since 21.02.2016 to date.
- 10. Copies of all the educational details of the child such as the name of the school in which the child is studying, the monthly fees structure of the school in which the child is studying, the class in which the child is reading etc.,
- 11. Copy of the affidavit of the name change of the child.
- 12. Copy of the affidavit of the single motherhood.
- 13. Copy of the BOB account (27530100010089) statement since inception to date. This is the account where the respondent has transferred money to the petitioner

on his own volition but the petitioner and her lawyer has concealed these facts.

- 14. The Cr.P.C. 239 discharge application (FIR No. 319 OF 2016, ACGR 5166 OF 2016) was rejected by the then Honourable LD. 2nd JM on 19.09.2018 based on the strong objection by the then State Public Prosecutor. Request this Honourable LD. Court to provide all the necessary documents based on which the discharge petition was rejected and the natural justice was denied to Shri Abhijit Palit and his parents along with the Cr.P.C. 207 application required documents.
- 15. Copies of all the bills/tax invoice/challan of the Streedhan articles as mentioned by the petitioner in paragraph-20 in the AC-272 of 2017 dated 27.01.2017 and in paragraph-20 in the AC M-83 of 2021 dated 27.01.2021.
- That Your Honour, the petitioner states that she has not received her Streedhan articles but the Charge Sheet in connection with the 498A/406/34 of the IPC dated 17.12.2016 states that she has received all her Streedhan articles including one gold chain (without producing a single bill or challan or tax invoice to date). The petitioner has signed in the ZIMMANAMA as well dated 02.10.2016. That Your Honour, the ex-husband of the petitioner have transferred all the relevant articles of the petitioner from Hyderabad to Kolkata via Kuber Logistics Bill No. 5113 dated 25.10.2016 which she has received but the petitioner has not disclosed the facts neither before the Protection Officer during the DV/DIR nor before this Court in these applications. The respondent also states that the father of the respondent has handed over all the relevant Streedhan articles dated 22.11.2016 at the Thakurpukur P.S. The respondent also states that the Streedhan articles were collected without producing a single bill/tax invoice/documents. Had this LD. Courts investigated and enquired properly these facts must have surfaced as her statement is a palpable lie.
- That Your Honour, the essential ingredient of the IPC 406 is entrustment of the dowry articles with proof of possession.
- The petitioner/ex-wife/aggrieved person should be able to produce the proof of ownership i.e., Bills/Tax Invoice/Challan/Photographs.
- In Jaswant Lal Vs. State AIR 1968 SC 700, the Hon'ble Supreme Court laid down that entrustment is an essential ingredient of an offence U/s 406 IPC.
- In Reshan Lal Vs. State AIR 1983 SC 631, the Hon'ble Supreme Court held that proof of entrustment is an essential ingredient of the offence.
- In Ram Narayan Vs. CBI 2003 (3) SSC 641, the Hon'ble Supreme Court held that no constitute an offence of criminal breach of trust, there must be an entrustment.
- In the judgement of Neera Singh Vs. State (Govt. of NCT of Delhi) and others, 138

(2007), DLT 152, the Hon'ble High Court of Delhi observed the mandate for the preparation of list of dowry articles at the time of marriage duly signed by both the parties. The petitioner and her family members are bound to disclose the source of such expenditure on marriage.

16. The exact date/time as to when the Dowry amount and gold jewelleries had been given to the respondent and his family members and in whose presence these items were given to the respondent as claimed in the following –

- The petitioner has alleged in paragraph-1 in the FIR No. 319 of 2016 (ACGR 5166 of 2016, 498A/406/34 of the IPC) dated 01.09.2016 that Shri Abhijit Palit and his father have taken Dowry. The exact Dowry amount and the medium of transaction need to be provided as documents or evidence. In reality, there was no exchange of any Dowry amount.
- The petitioner has alleged in paragraph-1 in the AC-272 of 2017 (DV) dated 27.01.2017 that Shri Abhijit Palit and his father have taken Dowry with jewelleries amounting to Rs. (.......) zero. The exact Dowry amount, the medium of transaction and the quantity as well as the type of jewelleries exchanged need to be provided along with the copies of the bills/tax invoice/challan.
- The petitioner has alleged in paragraph-1 in the AC M-83 of 2021 (Cr.P.C. 125) dated 27.01.2021 that the mother and father of Shri Abhijit Palit have taken Dowry as jewelleries. The mother of the respondent, Smt. Kalpana Palit was not present at the marriage venue dated 27.02.2015 and 28.02.2015 respectively at Kanpur as she was in Kolkata. Then how the petitioner was able to hand over all the jewelleries to the mother of the respondent is not known to the respondent. The Honourable LD. Court need to explain this.
- Note: Three different statements have been made by the petitioner in three different applications in paragraph-1.

Case numbers: (1) ACGR 5166 OF 2016 (FIR NO. 319 OF 2016) DATED 01.09.2016, 2ND JM, ALIPORE, (2) DV AC-272 OF 2017 DATED 27.01.2017, 2ND JM, ALIPORE, (3) AC M-83 OF 2021, DATED 27.01.2021, IST JM, ALIPORE, UNDER THE JUDGESHIP OF THE HONOURABLE LD. DISTRICT and SESSIONS JUDGE, ALIPORE, SOUTH 24 PARGANAS, WEST BENGAL.

I have won the ex-parte decree of divorce against my ex-wife on 24.04.2017 based on cruelty & desertion under section 13(1)(ia)(ib) vide order no. MAT SUITE 248 of 2016.

Period to which the information relates: 2016 - 2022.

In the light of the above mentioned background, please provide the following information under section 2(f) and 2(j) of the RTI Act:

- (A) Reason for overlooking the MAT SUITE Order No. 248 of 2016 by this Honourable LD. Court.
- (B) The petitioner has used the same points and the same events in the ACGR-5166 of 2016 (FIR No. 319 of 2016) dated 01.09.2016 (2nd JM) and in the DV AC-272 of 2017 dated 27.01.2017 (2nd JM) and in the AC M-83 of 2021 dated 27.01.2021 (Ist JM). The reason for accepting such applications by this Honourable LD. Courts where there is a violation of Article 20(2) of the Indian Constitution.
- (C) The reason for sending notice for hearing in two different Courts in three different cases based on the same points and the same events without providing a single evidence to date.
- (D) The reason for overlooking the last sentence of the Paragraph 22 in the Cr.P.C. 125 application where the petitioner has stated that "she till now wants to stay with the Opposite Party wherever he wants to stay" which proves that the petitioner has willfully and deliberately deserted the respondent without any valid reason.
- (E) The reason for overlooking the FIR against the petitioner and her parental relatives being FIR No. 82 of 2020 dated 11.02.2020 Under Sections 341/323/427/506/34 of the I.P.C. and then the Police upon the conclusion of the investigation has submitted a Charge Sheet Under Sections 448/323/506/34 of the I.P.C.
- (F) Reason for overlooking the police complaints against the petitioner and her parental relatives in different Police Stations 08.04.2016 at the Nimta P.S., 12.05.2016 at the Nimta P.S., 14.05.2016 at the Nimta P.S., GDE No. 700 of 2016., 02.06.2016 at the Thakurpukur P.S., 11.06.2016 at the Balasore Town P.S., SD No. 259, 260, 261, 263 and 264, 12.06.2016 at the Nimta P.S., GDE No. 614 of 2016., 12.06.2016 the Medical Examination of Shri Abhijit Palit was conducted by a Government Doctor at the North Dum Dum Municipal Hospital under the purview of the then Sub-inspector of the Nimta P.S., 6394 of 2016., 12.08.2016 at the Nimta P.S., 20.08.2016 at the Thakurpukur P.S.

- (G) The Honourable LD. Courts have completely overlooked the fact that the respondent (Shri Abhijit Palit) is legally married to Mrs. Lipika Palit since 4th May 2018. The petitioner has been deliberately and intentionally claiming to be the legally married wife of the respondent everywhere which is an Abuse of the Process of Law. The reason for the LD. Courts being silent in this matter is not known to the respondent.
- (H) The reasons as per the records for not referring the two notable judgements in my case related to the ACGR 5166 of 2016 (1) Anju vs Govt. Of Nct Of Delhi & Ors.; on 4 February, 2019, CRL. REV. P. 730/2016 & (2) Alok Lodhi & Ors. Vs. State of MP & Anr., MCRC 47904 of 2019.
- (I) The then I.O. of the Thakurpukur P.S. named LSI BABY HAZRA during the Cr.P.C. 41A Interrogation in the ACGR-5166 of 2016 (FIR No. 319 of 2016) told Shri Ashoke Kumar Palit (respondent's father) that "As your son have filed divorce petition so Nivedita Palit nee.......Roy have filed 498A". The reason for accepting such an application by the LD. Court where the application is based on revenge and which is after thought is not known to the respondent and his parents. The petitioner's ex-matrimonial house is at Nimta which falls under the jurisdiction of the Honourable LD. District and Sessions Judge, Barasat, North 24 Parganas. If the incidents were genuine, the petitioner could have easily filed 498A at the Barasat Court but she filed 498A not only after receiving the divorce petition summon but also at the Alipore Court, South 24 Parganas which have a territorial jurisdiction.

In the light of the above mentioned background, please provide the following information under section 2(f) and 2(j) of the RTI Act:

- 1. Copy of the E-TICKET from Howrah to Balasore dated 26.05.2016 as mentioned by the petitioner in paragraph-15 in the AC-272 of 2017 dated 27.01.2017 and in paragraph-16 in the FIR No. 319 of 2016 (ACGR 5166 of 2016) dated 01.09.2016 and in paragraph-15 in the AC M-83 of 2021 dated 27.01.2021.
- 2. Copy of the E-TICKET from Balasore to Ongole dated 03.06.2016 and from Ongole to Balasore as mentioned by the petitioner in paragraph-15 in the AC-272 of 2017 dated 27.01.2017 and in paragraph-16 in the FIR No. 319 of 2016 (ACGR 5166 of 2016) dated 01.09.2016 and in paragraph-15 in the AC M-83 of 2021 dated 27.01.2021.

- 3. Copies of all the medical reports of injury of Mrs. Nibha Roy (mother of the petitioner), Miss Nandita Roy (younger sister of the petitioner) and Nivedita Palit nee.....Roy (petitioner) as mentioned by the petitioner in paragraph-15 in the AC-272 of 2017 dated 27.01.2017 and in paragraph-16 in the FIR No. 319 of 2016 (ACGR 5166 of 2016) dated 01.09.2016 and in paragraph-15 in the AC M-83 of 2021 dated 27.01.2021.
- 4. Copies of all the medical reports of injury based on the alleged physical assault as mentioned by the petitioner in paragraph-6 in the AC-272 of 2017 dated 27.01.2017 and in paragraph-7 in the FIR No. 319 of 2016 (ACGR 5166 of 2016) dated 01.09.2016 and in paragraph-6 in the AC M-83 of 2021 dated 27.01.2021.
- 5. The exact date/time/place/year of the alleged sexual assault as mentioned by the petitioner in paragraph-7 in the AC-272 of 2017 dated 27.01.2017 and in paragraph-8 in the FIR No. 319 of 2016 (ACGR 5166 of 2016) dated 01.09.2016 and in paragraph-7 in the AC M-83 of 2021 dated 27.01.2021.
- 6. Copies of all the medical reports of injury based on the alleged physical assault as mentioned by the petitioner in paragraph-9 in the AC-272 of 2017 dated 27.01.2017 and in paragraph-10 in the FIR No. 319 of 2016 (ACGR 5166 of 2016) dated 01.09.2016 and in paragraph-9 in the AC M-83 of 2021 dated 27.01.2021.
- 7. The exact date/time/place/year of the alleged sexual assault as mentioned by the petitioner in paragraph-11 in the AC-272 of 2017 dated 27.01.2017 and in paragraph-12 in the FIR No. 319 of 2016 (ACGR 5166 of 2016) dated 01.09.2016 and in paragraph-11 in the AC M-83 of 2021 dated 27.01.2021.
- 8. The exact date/time/place/year of the alleged sexual assault as mentioned by the petitioner in paragraph-13 in the AC-272 of 2017 dated 27.01.2017 and in paragraph-14 in the FIR No. 319 of 2016 (ACGR 5166 of 2016) dated 01.09.2016 and in paragraph-13 in the AC M-83 of 2021 dated 27.01.2021. The petitioner has also alleged of sexual abuse on one day early May 2016. The respondent wishes to know that exact date.
- 9. Copies of all the medical reports of the child (Anish Kumar Palit) including the vaccination details since 21.02.2016 to date.
- 10. Copies of all the educational details of the child such as the name of the school in which the child is studying, the monthly fees structure of the school in

which the child is studying, the class in which the child is reading etc.,

- 11. Copy of the affidavit of the name change of the child.
- 12. Copy of the affidavit of the single motherhood.
- 13. Copy of the BOB account (27530100010089) statement since inception to date. This is the account where the respondent has transferred money to the petitioner on his own volition but the petitioner and her lawyer has concealed these facts.
- 14. The Cr.P.C. 239 discharge application (FIR No. 319 OF 2016, ACGR 5166 OF 2016) was rejected by the then Honourable LD. 2nd JM on 19.09.2018 based on the strong objection by the then State Public Prosecutor. Request this Honourable LD. Court to provide all the necessary documents based on which the discharge petition was rejected and the natural justice was denied to Shri Abhijit Palit and his parents along with the Cr.P.C. 207 application required documents.
- 15. Copies of all the bills/tax invoice/challan of the Streedhan articles as mentioned by the petitioner in paragraph-20 in the AC-272 of 2017 dated 27.01.2017 and in paragraph-20 in the AC M-83 of 2021 dated 27.01.2021.
- That Your Honour, the petitioner states that she has not received her Streedhan articles but the Charge Sheet in connection with the 498A/406/34 of the IPC dated 17.12.2016 states that she has received all her Streedhan articles including one gold chain (without producing a single bill or challan or tax invoice to date). The petitioner has signed in the ZIMMANAMA as well dated 02.10.2016. That Your Honour, the ex-husband of the petitioner have transferred all the relevant articles of the petitioner from Hyderabad to Kolkata via Kuber Logistics Bill No. 5113 dated 25.10.2016 which she has received but the petitioner has not disclosed the facts neither before the Protection Officer during the DV/DIR nor before this Court in these applications. The respondent also states that the father of the respondent has handed over all the relevant Streedhan articles dated 22.11.2016 at the Thakurpukur P.S. The respondent also states that the Streedhan articles were collected without producing a single bill/tax invoice/documents. Had this LD. Courts investigated and enquired properly these facts must have surfaced as her statement is a palpable lie.
- That Your Honour, the essential ingredient of the IPC 406 is entrustment of the dowry articles with proof of possession.

- The petitioner/ex-wife/aggrieved person should be able to produce the proof of ownership i.e., Bills/Tax Invoice/Challan/Photographs.
- In Jaswant Lal Vs. State AIR 1968 SC 700, the Hon'ble Supreme Court laid down that entrustment is an essential ingredient of an offence U/s 406 IPC.
- In Reshan Lal Vs. State AIR 1983 SC 631, the Hon'ble Supreme Court held that proof of entrustment is an essential ingredient of the offence.
- In Ram Narayan Vs. CBI 2003 (3) SSC 641, the Hon'ble Supreme Court held that no constitute an offence of criminal breach of trust, there must be an entrustment.
- In the judgement of Neera Singh Vs. State (Govt. of NCT of Delhi) and others, 138 (2007), DLT 152, the Hon'ble High Court of Delhi observed the mandate for the preparation of list of dowry articles at the time of marriage duly signed by both the parties. The petitioner and her family members are bound to disclose the source of such expenditure on marriage.
- 16. The exact date/time as to when the Dowry amount and gold jewelleries had been given to the respondent and his family members and in whose presence these items were given to the respondent as claimed in the following –
- The petitioner has alleged in paragraph-1 in the FIR No. 319 of 2016 (ACGR 5166 of 2016, 498A/406/34 of the IPC) dated 01.09.2016 that Shri Abhijit Palit and his father have taken Dowry. The exact Dowry amount and the medium of transaction need to be provided as documents or evidence. In reality, there was no exchange of any Dowry amount.
- The petitioner has alleged in paragraph-1 in the AC-272 of 2017 (DV) dated 27.01.2017 that Shri Abhijit Palit and his father have taken Dowry with Jewelleries amounting to Rs. (......) zero. The exact Dowry amount, the medium of transaction and the quantity as well as the type of jewelleries exchanged need to be provided along with the copies of the bills/tax invoice/challan.
- The petitioner has alleged in paragraph-1 in the AC M-83 of 2021 (Cr.P.C. 125) dated 27.01.2021 that the mother and father of Shri Abhijit Palit have taken Dowry as jewelleries. The mother of the respondent, Smt. Kalpana Palit was not present at the marriage venue dated 27.02.2015 and 28.02.2015 respectively at Kanpur as she was in Kolkata. Then how the petitioner was able to hand over all the jewelleries to the mother of the respondent is not known to the respondent. The Honourable LD. Court need to explain this.
- Note: Three different statements have been made by the petitioner in three different applications in paragraph-1.

6. Particulars of Decision of SPIO:

No response received

7. Brief facts of the case:

Reason for overlooking the MAT SUITE Order No. 248 of 2016 by this Honourable LD. Court and allowing the petitioner to file AC M-83 of 2021 in the Court of the LD. Ist JM where the ex-parte decree of divorce order has already been passed based on U/s 13(1)(ia)(ib). (2) Reason for granting interim maintenance to the petitioner in AC-272 of 2017 by the LD. 2nd JM despite the petitioner willfully and deliberately deserting the respondent without any sufficient or cogent reason. (3) Reason for sending notice to the respondent for hearing in three different cases in two different Courts by overlooking the fact that same points and same events have been used and also by overlooking Article 20(2) of the Indian Constitution.

The copy of the RTI application has been attached herewith as Annexure 1.

- 8. Reasons/grounds for this appeal:
- 1. As there was no reply from the Public Information Officer, to the RTI application dated 05/05/2022 within 30 days, an appeal is preferred before the First Appellate Authority under the Section 19 (1) of the Right to Information Act, 2005.
- 2. Under the RTI Act, 2005, a PIO is obliged to provide access to information to a citizen unless as stipulated by Section 7(1), furnishing of such information is covered by one of the exemptions provided under Section 8 or Section 9 of the RTI Act.
- 3. The PIO has failed to discharge its duties and obligations and has adopted a lackadaisical approach towards dealing with the RTI application by not responding within 30 days of the application.
- 4. The PIO has failed to inform the applicant as to why this information has not been disclosed to the applicant and its reasons thereof. Section 4(1)(d) of the RTI

Act clearly lays down that every public authority shall have to disclose the reasons for its decisions to the affected persons.

5. It is obligatory upon the PIO to disclose the information as requested by the applicant. The request of the applicant squarely falls within the definition of Right To Information Under Section 2(j) of RTI Act read with Section 2(f) and 2(i) relating to the definition of information and record. The applicant in his RTI application has clearly enumerated the information which he desires and there is no ground whatsoever for the PIO to not to provide him the complete information.


