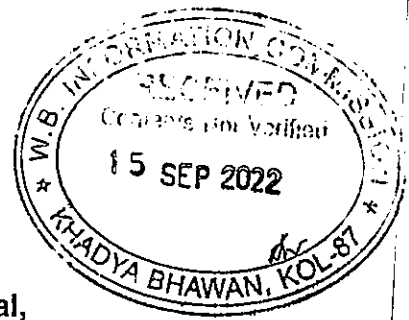

Being aggrieved by the order passed by the said First Appellate Authority on 18/7/2022 vide his Memo No.2292/DRSR-16/1/2022/ESST SEC-DRSR, I am filling this Appeal petition before you to get a proper justice.

That I was submitted an application on 17/5/2022 under the RTI Act, 2005 seeking some Informations before the SPIO & ACSR, W.B. with affixing the requisite Court Fees in my said application which was duly received by the said SPIO on 19/5/2022 and the said application has latter transferred to the SPIO & DR, North 24 Parganas on 23/5/2022 by the said SPIO & ACSR with a request to him to provide the informations as I sought in my said RTI application directly to me i.e the applicant. But the concerned SPIO has not responded accordingly and thus being aggrieved I had made my First Appeal before the First Appellate Authority on 13/7/2022. Unfortunately, the order passed by the First Appellate Authority is not proper and clear in my view as I have been affixed the requisite Court Fees in my said RTI Application as per provisions of RTI Act, 2005 and till today I have not received the informations as I sought in my said RTI application under the RTI Act, 2005.

Now I would request your Honour to pass necessary order/orders asking the concerned authorities of Directorate of Registration and Stamp Revenue, Govt. of West Bengal to furnish the informations directly to me as I sought in my RTI application dated 17/5/2022 under RTI Act, 2005 for the ends of justice. *after condonation of delay*

In reply to the appeal dated 13.07.2022 filed on 14.07.2022 by Smt. Dipa Baisya before the First Appellate Authority u/s 19(1) of the RTI Act , 2005 this is to inform him that as per guideline No. 9 issued by the Department of Personnel & Training , Government of India vide OM No. 1/3/2008-IR dated 25.04.2008 on the RTI Act , 2005 (may be searched from Goolge) it is beyond the scope of the Act to create information ; or to interpret information or to solve the problems raised by the applicants ; or to furnish replies to hypothetical questions.

In reply to the application dt. 17.05.22 received ^{by IAS SPIO} on 19.05.2022 under the RTI Act , 2005 submitted by the applicant Smt. Dipa Baisya before the SPIO & ACSR , W.B. it is found that the SPIO & ACSR , W.B. has transferred the application to the SPIO & D.R. , N-24 Pgs. on 23.05.22 and he has requested the said SPIO to provide the requisite accessible information as sought for by the applicant directly to the applicant with an intimation to this Directorate. But the concerned SPIO has not responded accordingly and being aggrieved, the applicant has made this appeal before the First Appellate Authority.

However , the SPIO & D.R., N-24 Pgs is directed to furnish only the accessible information as per RTI Act , 2005 for the said application to the applicant without any delay if the applicant approaches his office on previous payment of requisite fees through proper procedure for the purpose .

With the above direction , the appeal stands disposed of.
However , if aggrieved , the party concerned may prefer second appeal before the State Chief Information Commissioner , West Bengal , Khadya Bhawan , 11A , Mirza Ghalib Street , Kolkata – 700087.

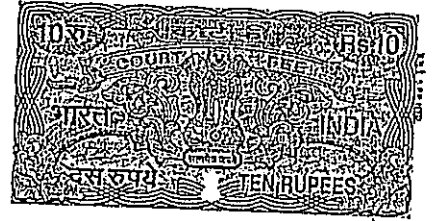

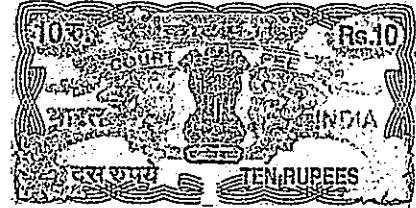

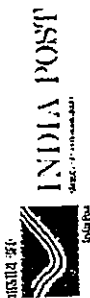
