
Neither the appellant nor the SPIO of the case are present for the hearing.





The SPIO of the case is present for hearing virtually while the appellant remained absent.

2. The matter was last heard by the Commission on 02.6.2025 wherein the Commission issued show cause to the CMOH & SPIO, Cooch Behar to explain as to the reason for his absence from hearing on that day. In reply Dated 17.6.2025, the CMOH & SPIO, Cooch Behar submitted that due to some urgent matter he could not attend the hearing. He also sought apology from the Commission and assured that recurrence of such mistake will not be repeated in future. The same is considered and accepted.

3. The appellant filed an RTI application on 19.1.2022 before the SPIO, Health and Family Welfare seeking to know the time of birth of the appellant. The said RTI application was transferred u/s 6(3) of the RTI Act, 2005 to the CMOH & SPIO, Cooch Behar on 02.2.2022 from the Assistant Secretary & SPIO, Department of Health & Family Welfare. The same was further transferred u/s 6(3) of the RTI Act, 2005 to the

MSVP & SPIO, MJN Medical College & Hospital, Cooch Behar on 17.2.2022. Not getting any reply, the appellant filed 1st appeal before the 1st Appellate Authority on 16.3.2022 and then filed 2nd appeal before the Commission on 26.4.2022. On perusal of the case records, it appears that a reply was furnished by the MSVP & SPIO, MJN Medical College & Hospital, Cooch Behar to the CMOH & SPIO, Cooch Behar on 17.6.2025 against the RTI application mentioning that the time of birth of the appellant could not be recovered as their old records had been lost due to bulk shifting issue but the same was not furnished to the appellant. If the documents / files are untraceable and/ or missing, the SPIO is directed to take following actions:

- i) He should lodge a G.D. Entry with the local Police Station about the missing /lost documents / files.
- ii) Appellant should be informed about this fact alongwith the Police Station's reference.
- iii) He should submit the same facts to the Commission in the form of an affidavit within two months' time.

4. A time of two months is given to the CMOH & SPIO, Cooch Behar to complete the exercise as per direction of the Commission. The appellant has absented herself from the hearing today also in spite of prior notice from the Commission and no reason for her absence from hearing has also been received by the Commission.

5. The matter will be taken up further once such compliance report as mentioned above is received by the Commission.

6. Let authenticated copies of the order be forwarded to all concerned.
