Facts on Record & Findings :

The SPIO of the case is present for the hearing in virtual mode while the appellant remained absent.

2. The appellant filed an RTI application on 25.9.2021 seeking two points of information regarding recruitment of MBBS doctors and related issues. Not getting information in time, the appellant filed 1st appeal before the 1st Appellate Authority on 1.11.2021 and 2nd appeal before the Commission on 8.2.2022.

3. The SPIO informed that no such RTI application seems to have been received by the public authority. However, after getting notice for today's hearing, they have come to know about the RTI application and 2nd appeal case under consideration. The SPIO also informed that requisite information is available and it will be possible

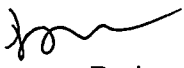

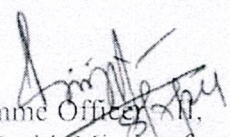

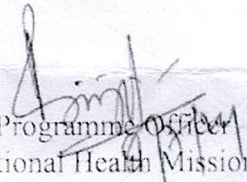
