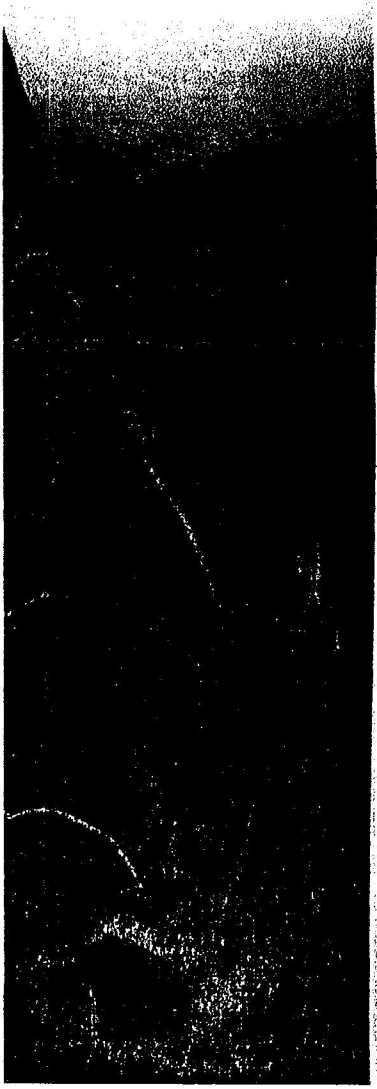

Facts on Record & Findings :

Shri Debashis Sengupta, Ld. Advocate, the representative of the SPIO is present for the hearing in physical mode while the appellant remained absent.

2. Ld. Advocate representing the NCCHM Collage & Hospital, mentioned before the Commission that the said institution is not a Government institution nor receives any fund for salary and other expenses. Only a small amount of Government aid is given to the institution for development purposes. The Commission also finds that the said Medical College and Hospital, even though has been recognized by Central Council for Homoeopathic and is affiliated with West Bengal Council for Homoeopathic and West Bengal University of Health Sciences, appears to be a private institution not substantially financed by the Central or State Government.

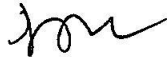


3. Only because of affiliation and / or recognition by Central / State Government authorities, this institution could not be treated as public authority u/s 2(h) of the RTI Act, 2005. Unless it can be shown that the institution has been created by an Act of Parliament / State Legislature or created by a Notification or Order of the Central or State Government and substantially financed by such Government, it cannot come under the purview of the RTI Act, 2005, as per provision contained in Section 2(h) of the said Act.

4. The hearing is accordingly deferred and during the next hearing, the Ld. Advocated representing the SPIO is required to present before the Commission averments on behalf of the said College and Hospital that they are not public authority under the provisions of RTI Act. The next hearing be fixed after 4 (four) weeks accordingly.

5. Let authenticated copies of the order be forwarded to all concerned.

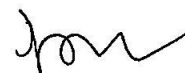
