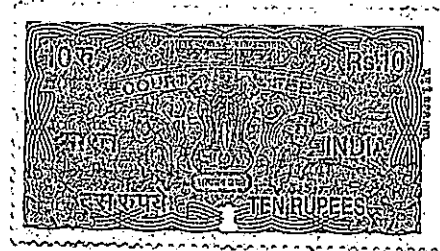

- An emergency meeting of all faculties was convened by the then Registrar and Vice Chancellor (Acting), Aliah University(AU), in the wake of violent protest made by students on 02.04.2018. After six months of the of the said emergency meeting , in the Memo No: AU/REG/0836/18 dt. 16.08.2018, Registrar, AU, has written to Dr. Sk. Safayat Ali in an another context , "...students and all other seven teachers of your department had to suffer a lot for and protested in many occasions". Kindly give the following information based on the above two incidents:
 - Have the students protested on 02.04.2018, for their suffering caused by Registrar and Vice Chancellor (Acting), AU?
 - Provide me the documentary evidence by which Registrar, AU, assessed the students and faculties of Civil Engineering Department 'had to suffer a lot' because of Dr. Ali.
- In the Memo No: AU/REG/0836/18 dt. 16.08.2018, Registrar, AU, has written to Dr. Sk. Safayat Ali, "I am to state that the grievances you wanted to record.....are baseless and not accepted at all". Kindly give the photocopy of the note sheets (prepared in the process of issuing the said memo) where reasons of not acceptance is recorded.
- In the Memo No: AU/REG/0836/18 dt. 16.08.2018, Registrar, AU, has written to Dr. Sk. Safayat Ali, "I advise you to ...develop a good and healthy relationship with other colleagues of your department ". Kindly give the documentary evidence by which Registrar, AU, comes into conclusion that Dr. Ali does not have good and healthy relation with other colleagues of his department. Has Registrar, AU, given same advice to other faculties of the Civil Engineering Department?
- Kindly give the photocopy of the entire note sheets, prepared in the process of allotment a separate cubical/room for the Chairman, Hostel Management Committee of Aliah University.

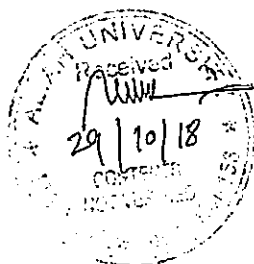
