

# Facts on Record & Findings:

The SPIO of the case is present for the hearing in virtual mode while the appellant remained absent.

- The appellant filed an RTI application on 07.08.2019 seeking thirteen points of 2. information relating to appointment of Data Entry Operators and related matters. A reply was given to the appellant on 02.01.2020 by the SPIO. In the mean time, not getting reply, the appellant filed first appeal before the First Appellate authority on 10.09.2019 and subsequently second appeal before the Commission on 08.12.2019.
- A perusal of the reply furnished by the SPIO indicates that replies were furnished against each of the queries while Query Nos.1 and 13 were not at all

comprehensible and therefore the SPIO could not furnish any reply to the same.

Furthermore, Query No.11 seeks reason for not punishing a particular individual and

Query No.12 seeks to know what will be the punishment given to such individual in

Both of these can not be termed as information under the provisions

contained in section 2 (f) and 2 (j) of the RTI Act, 2005 and therefore, the SPIO could

not have given any replies on these two queries. Replies to remaining queries are in

order and no infirmity was noticed in the same.

The appellant has not turned up for hearing in spite of prior notice from the 4.

Commission and no reason for his absence from hearing today has also been

received. It also appears that due reply was furnished to the appellant after filing first

appeal and subsequently second appeal in the matter.

In view of the above, there is nothing further to proceed with the second 5.

appeal case under consideration and the same is liable to be disposed accordingly.

Decision:

In view of the facts and findings as mentioned hereinabove, the second

appeal is accordingly disposed of and closed.
