
Sir

I Mrs. Susama Chakraborty w/o Late Bisweswar Chakraborty most respectfully submit as follows:

1. That I am well seized and possessed of the land and building more fully mentioned in the schedule hereunder.
2. That on 04th September and 6th September 2022, men and agents of Mohanpur Gram Panchayat demolished my boundary wall. I want the reference and date of the memo of order of demolition (hard copy) as passed by Mohanpur gram panchayat vide which my boundary wall was demolished by the Panchayat official.
3. Previously I have made a RTI to B.D.O, Barrackpore Block-II about the same, dated 31/10/2022 (documents enclosed herewith – marked with **Annexure A**), against which I received a reply from Mohanpur gram panchayat with memo no. 277/MGP/2022 dated 02/12/2022 which requested me to present myself to Mohanpur gram panchayat office along with my current Panchayat Tax Receipt (document enclosed herewith – marked as **Annexure B**). I'm a 73 year old person and due to my unwell state my son went to the office and presented all appropriate documents as requested by them.
4. Since within 45 days I have not received any reply for my previous RTI, so I appealed for another RTI to The Office of District Magistrate, North 24 Parganas dated 18/01/2023 (documents enclosed herewith – marked as **Annexure C**), against which The Office of District Magistrate, North 24 parganas forwarded the same to B.D.O Barrackpore Block-II to take further action memo no. 772/XL/RTI dated 27/01/2023 (document copy that has been sent to me from office of District Magistrate as a reference is enclosed herewith – marked as **Annexure D**).
5. After which my lawyer made an application to B.D.O, Barrackpore block-II dated 01/03/2023 for the information regarding no response from their B.D.O. office even after compliance of all proper documents requested by Mohanpur gram panchayat, also requesting them to reply as soon as possible (document enclosed herewith – marked as **Annexure E**), but unfortunately I have not yet received any reply from B.D.O., Barrackpore block-II.
6. I have also attached the scanned colour photo of the scheme of the said project which is encased in my neighbor's (Mr. Debabrata Dam Choudhury) boundary wall (document enclosed herewith – marked as **Annexure F**).

7. I have attached my self attested photocopy of Aadhar card with the appeal (document enclosed herewith – marked as **Annexure G**)
8. Hence I am requesting for the same information under sec 6 of RTI ACT 2005 as amended up to date.
9. That I am enclosing court fee valued at RS 10/- herewith. (27F 355373).
10. I am ready to pay fees for additional expenses.
11. That I am an Indian by citizenship and I am requesting for the information as an Indian.


