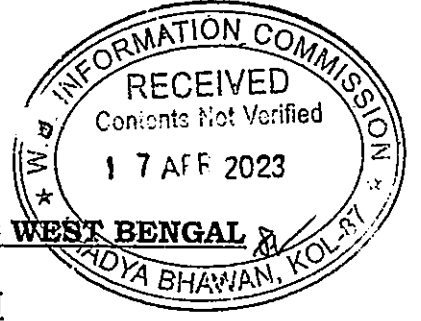

1. That the action of the SPIO is unbecoming of an information officer, as I (the applicant) had sought for information and have not received it even after thirty days, which is the time limit as envisaged in the RTI Act, 2005.

2. That the SPIO, seems to be oblivious of the fact that, there is no scope for "denial" by simple inaction in RTI Act, 2005.

3. That the SPIO, has not even bothered to provide any reason for his Denial but preferred a situation of mysterious and uncanny silence from his end.

So it is crystal clear, that the concerned SPIO, has denied information and such action of him an attempt to jeopardize the constitutional right of a citizen and thus is surely a fittest case to be tested in the touchstone of your quasi-judicial capacity.

Hence is this instant "Appeal".

1. Issue specific order, directing the concerned SPIO to provide me the specific information, as sought for.

2. Issue "Notice of Hearing" to all concerned to give an opportunity of

- 3 A candidate shall sit at the centre assigned to him/her and shall abide by the order of the Officer-in-Charge regarding the seating arrangements'.
- 4 The examination of a candidate is liable to be cancelled, if he/she sits at a centre other than the one assigned to him/her or refuses to abide by the instructions of the Office-in-Charge regarding seating arrangements' of Candidates.
- 5 A candidate shall not be allowed to leave the examination hall before the expiry of the duration of the examination.
- 6 A candidate shall not be permitted to possess books, written notes, pager, mobile phones, scientific calculator, digital diary, any type of electronic device or any type of scribbling in the examination hall during the examination period.
- 7 A candidate shall be debarred from the examination hall if he or she does not abide by the rules regarding the articles mentioned in Clause 6 above and / other rules as per provisions made by the Officer-in-Charge of the respective examination centre.
- 8 A candidate shall be held guilty of misconduct or malpractice, if
 - a. he/she is found to be in possession of books, written notes, pager, mobile phones, scientific calculator with memory, digital diary, any electronic device or any type of scribbling that may have a bearing on the subject in which a candidate is appearing irrespective of whether such article(s) have been used or not; inside the examination hall after the commencement of the examination.
 - b. he or she helps by writing answers on another candidate's OMR answer script or allows another candidate to write answer in his/her own OMR answer script or he/she helps in any manner or tries to obtain any help in any manner from any other candidate or any other person;
 - c. he/she communicates with another candidate or any other person whether inside or outside the examination hall for helping him/her in answering questions;
 - d. indecorous writing or indecorous drawing or political slogans are found in his/her answer script;
 - e. he/she leaves the examination hall without submitting the OMR answer script and the question booklet to the invigilator of the room or any other authorised person;
 - f. he/she leaves the examination hall with the answer script or carries from the examination hall the question booklet during the hours of examination or goes out of the examination hall with any of the above noted items after the examination is over;
 - g. he or she allows himself or herself to be impersonated in the examination hall.
 - h. he or she falsely writes his/her name, roll number and other information's in his/her OMR answer script;
 - i. he or she leaves the examination hall without recording his or her attendance on the attendance roll;
 - j. he or she encloses currency note with the OMR answer script with an intention of offering illegal gratification to an examiner, or offer illegal gratification to the invigilator or other person connected with the examination;
 - k. he or she indulges in any kind of misbehaviour, misdemeanour or unruly behaviour such as intimidation or assault of an invigilator or any other person connected with the examination, either inside or outside the examination hall, and
 - l. he/she refuses to comply with orders of the Officer-in-Charge regarding seating arrangements or other matter in the examination hall.

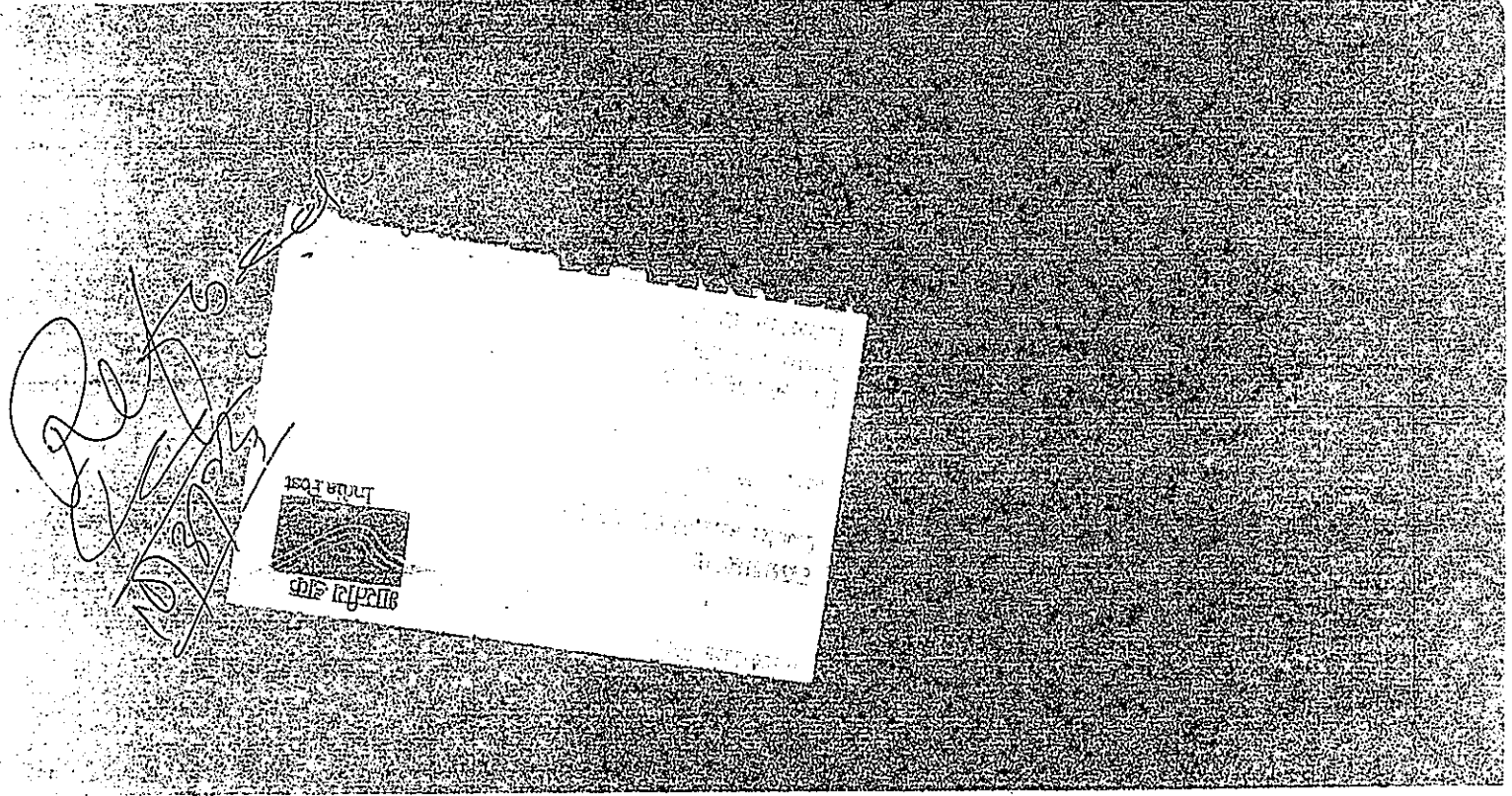

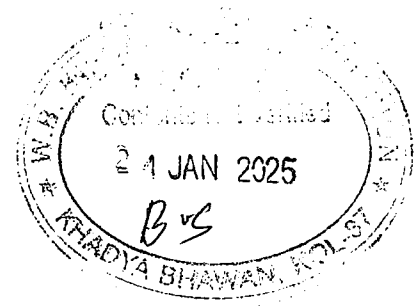

In respect to the query Nos. 1 & 2 of the appellant, I am directed to inform you that the information is currently not available with the Board.

In respect to the query Nos. 3 & 4 : The Answer Keys of different question booklet code of TET-2017 has already been published in the official website of the Board vide memo nos.1124/BPE/2021 dated 15/09/2021 and 740/BPE/2022 dated 19/05/2022 which is still available in public domain.

In respect to the query No. 5 : As per NCTE guidelines, 60% out of 150 marks is required for an Unreserved Category Candidate to qualify in TET-2017.

55% out of 150 marks is required for a Reserved Category Candidate to qualify in TET-2017.
