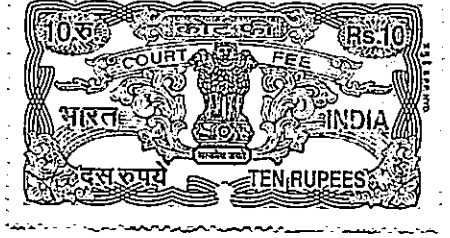

Facts on Record:

1. Ms. Murshida Khatun (hereinafter referred to as the appellant) a candidate of 1st SLST, 2016 (AT) for Physical Edu. & Work Edu. (Upper Primary Level) in Bengali, Category OBC-B and 3rd RLST, 2016 for non-teaching staff (Group D) Exam, filed two RTI applications on the same date noted above to the SPIO, West Bengal Central School Service Commission seeking the following information;


A) Appeal no. 104446, RTI dated 02.01.2023 for 1st SLST, 2016 (AT) Exam;

- i) Marks obtained in details (Written + Academic) by me.
- ii) Final Answer Keys of Work Education (Pass) and OMR sheet of answer scripts of mine.

- iii) Marks obtained in details (Written + Examination) by the last candidate called for Personality Test according to the count of final vacancy available in Bengali Medium for OBC-B Female category.
- B) Appeal no. 104448, RTI dated 02.01.2023 for 3rd SLST (Group D);
- i) OMR sheet as answered by me (Group D Peon).
- ii) Marks obtained by me in 3rd RLST, 2016 for non-teaching staff (Group D).

2. Grounds for second appeal were non-response of the SPIO and relief sought is to provide the information.
3. The SPIO, WBCSSC, in his ATR, submitted that information has been provided to the appellant vide memo nos. (i) 473/1(1)/R-2/CSSC/RTI/2024 dated 29.11.2024 (for Appeal no. 104446) and (ii)(a) 474/1(1)/R-2/CSSC/RTI/2024 dated 29.11.2024 (b) 29/5656 (XV-I)/CSSC/RTI/2024 dated 29.012024 (for Appeal no. 104448).

Decision and Deliberation

4. The appellant was present in person and the SPIO was present virtually.
5. The appellant expressed her dissatisfaction with the reply provided by the SPIO, WBCSSC, submitting that she should have got more marks than shown in the reply. It was explained to the appellant that this is a grievance and the RTI Act is not for redressal of grievances but only for supply of information. Such grievance does not fall within the purview / ambit of the RTI Act. For redressal, the appellant may approach an appropriate forum.
6. The Commission, after deliberation and discussion, observed that the appellant has been replied adequately, vide para-3 above. The case is closed.
7. The matter is disposed of.


