Sir,

I am working as Senior Information Scientist at the University of Burdwan since 03/07/2001. The authority of my University given an extremely illegal punishment to me and Professor Sripati Mukhopadhyay (Dept. of Computer Science, The University of Burdwan) without proper investigation, without evidences and without giving any opportunity for self defense in 2005.

The authority realized that the charges imposed were baseless and the punishments were unjustly in 2015.

Surprisingly, the authority had waived all punishment from Professor Sripati Mukhopadhyay in same case with restoration of financial losses suffered by him in 2015 <u>except myself</u>.

After considering my repeated appeals the authority has waived all punishment from me in 2022 without restoration of financial losses suffered by me in same case.

Then, I have applied to SPIO, the University Burdwan for seeking information/documents behind this discrimination. The SPIO denied to give me such documents/information showing excuse that ",,,,,,clarification which do not fall under the purview of RTI Act 2005". Then as per RTI Act 2005, I have applied to the Registrar and Appellate Authority of the University of Burdwan for the same. But I did not get any response from him till date.

Sir, I never demand any clarification rather I demand proper documents/Information for which I have not been given proper justice as per Professor Sripati Mukhopadhyay in same case.

Therefore, I will be highly obliged if you kindly take necessary action as per RTI Act 2005.



- 1. Received the notice of Hearing no. 6517-WBIC/RTI/A/104467/1174/2025 dated 03.12.2025 from West Bengal Information Commission.
- 2 The opposite party herein before dealing with the specific allegations and/or submissions and/or contention of the complaint in the said appeal wishes to place on record the following facts.
 - a) That the then SPIO received the RTI application dated 24/01/2023 of Dr Bikash Mukhopadhyay (the applicant) on even date: (copy enclosed)
 - b) That after receiving the RTI application, the then SPIO forthwith sent the same to the concerned department for providing necessary information, if any, as requested by the appellant;
 - c) That after having intense look into the application so filed by the appellant, the then SPIO made a reply vide this office letter no. BU/RTI/SPIO (054)/2022(2)/ 2023(1)/20 dated 20.02.2023 which is self-explanatory (copy enclosed)
 - d) That from the RTI application it is very clear the petitioner wanted the basis on which an order no.RE/T/II/247(Pt)/756/1(5) dated 17.02.2015 (copy enclosed) was served upon and also as to the basis on which the resolution of a meeting held on 05.11.2022 was taken; (copy enclosed)
 - e) That things may be ascertained from the RTI application as the petitioner sought clarification in the form of information/ documentary evidences for the decision taken by the University authority which is reflected through the orders or resolution so passed by the University authority or committee constituted by the University respectively;
 - f) That considering the entire petition, the SPIO acted upon accordingly.

Now that being the position, it is affirmed that the then SPIO acted by following the RTI Act, 2005 and with an apposite reply as it may be ascertained from the RTI application dated 24.01.2023 that the petitioner wanted clarification/ basis/documentary evidences on which an order was passed by the University or a committee took decision. Now, why a decision taken or order passed by the authority or what was the basis of such act is absolutely beyond the scope of the RTI Act, 2005, if otherwise not documented. The reply of the then SPIO clearly pointed out this very reason in an appropriate manner.

Nevertheless, the written submissions by the SPIO on the RTI application of the complainant along with the orders/resolution of the committee in question are placed before the Learned Commission.

I do hereby undertake to comply with the order as passed by this Learned Commission.


