Sir,

I have submitted an application u/s 6(1) of RTI Act 2005 before the BL & LRO, Bankura-I (SPIO) dated 16.01.2023 through Registered post, but the SPIO did not provide information though the stipulated period has elapsed. So, I being the applicant filed the instant appeal u/s 19(1) of RTI Act, 2005 on 28.02.2023. Then I got a copy of information from the 1st appellate authority. In reply to the intimation copy bearing memo no- 1928(2)/RTI/Appeal-16/23 dated 31/03/2023. I gave a reminder on 02.05.2023 about the order of the 1st appellate Authority to the BL & LRO, Bankura-I to act according to the provision of the said Act. Henceforth, I am filling 2nd appeal to you.

So, I request you to direct the concerned authorities to furnish information (as per enclosed photocopy) at the earliest. I also request you to impose penalty u/s 20 or any other punishment as per said law on the SPIO and the First Appellate Authority to protect the sanctity of the RTI Act, 2005 as it is a blatant violation of the RTI Act, 2005.

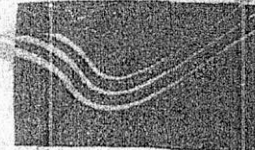

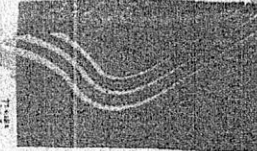

Reason for appeal: The SPIO was required to provide information within 30 days u/s 7(1) of the Act. However, the SPIO is being derelict in his duty knowingly, and thus violated the guidelines of the Govt of West Bengal, and is deliberately wasting the time and resource of the appellant.

Since, the SPIO failed to furnish any information within the specified time, the information sought for should be provided by your good office free of cost as early as possible u/s 7(6) of the Act.

Whereas, it appears from the appeal petition that Md. Samim Aktar Molla submitted an application u/s 6 (1) of RTI Act, 2005 before the Block Land & Land Reforms officer, Bankura-I dated 16.01.2023 through speed post for obtaining information. The same had been delivered on 17.01.2023 as tracking report.

It is also learnt that the concerned BL&LRO did not provide information to the appeal petitioner though the stipulated period has been elapsed.

So, the applicant filed the instant appeal u/s 19(1) of RTI Act, 2005 on 28.02.2023.

According to the provision of the of said act required information should be furnished, if any within the stipulated period i.e., within one month from the date of the receipt of the application. However, the BL&LRO, Bankura-I did not follow the provision.

Hence, the BL&LRO, Bankura-I is directed to act according to the provision of the said act and directed to furnish available information in his custody according to the queries of the application within 02 (two) weeks from the date of receipt of this order to the appeal petitioner with a compliance to the SPIO & Dy. DL&LRO, Bankura.

Thus, the RTI Appeal Petition is disposed of.
