11	Grounds for the prayer or relief	I. That despite having made an application for obtaining information from the abovementioned SPIO,

received on 12/12/2022, and more than 30 days have passed from the said date, there have been no communication from the department to me regarding the requested information.

- II. As per section 7(1) the State Public Information Officer is bound to furnish the requested information, or request for additional fee required for the application, within 30 days from the receipt of the application for information as per section 6(1) of the RTI Act, 2006.
- III. Thereafter an application of First Appeal was made dated 24/01/23 (duly received by the First Appellate Authority on 24/01/2023) as per section 19(1) of the Right to Information Act, 2005 which was also not responded to by the public appellate authority.
- IV. The appellant humbly submits that this action of the refusing to respond to the appeal application is violative of my rights under the Right to Information Act, 2005. Furthermore, the public authority is clearly violating section 7(1) and 19(1) of the Right to Information Act, 2005.
- V. It is pertinent to mention that under the Right to Information Act, 2005 the public authority has the duty under section 5(4) to seek assistance of relevant

		<p>officer for furnishing information as sought by applicant under section 6(1) of the Right to Information Act, 2005. Furthermore, the authority is empowered to transfer the application under section 6(3) of the abovementioned law. This implies that the authority in question is bound to give some response to the applicant or appellant as the case may be in regard to his application or appeal.</p> <p>VI.
