

### Facts on Record:

ii) Kindly furnish me the present status of 51 BMR files out of 81 files within the period from 01.01.2017 to 30.06.2018 (ward no.1 to 6) which are not yet been regularised against retention fees.

iii) Kindly furnish me with certified documents of order for Self Demonization notice if issued from the Building Department. If such notices issued against above said BMR files, since Landlord /Developer were carried out the orders or not? If they did not carry the same, how many numbers of BMR (unauthorised floors) have been demolished by the Building Department?

2. Ground for second appeal was non-response of SPIO and relief sought is to provide the information.

3. The SPIO replied to the appellant vide memo no.305/RTI/AE/Bldg/25 dated 15-5-2025.

### Decision and Deliberation

4. The appellant was absent despite the option of virtual hearing. He has neither sent any information nor any representative. He was not contactable on phone either. The SPIO was present virtually.

5. It is seen that the appellant has been replied vide para 3 above. Going through the queries of the RTI application, it is seen that the appellant has been seeking information which are exempted u/s 8 (1) (e) and (j) RTI Act. The case is closed.

6. The matter is disposed of.
