Sir,

That on 10/01/2023 an application was made under The Right to Information Act, 2005 for information leading to the action taken against Mr. Samit Pahari in reference to the writ petition vide W.P. 2403 (W) of 2008 filed before the Hon'ble High Court at Calcutta for plagiarism of Phd Thesis.

In the said application vide no. JU/RTI/375(ii)/23 the following questions were asked:

- 1) Whether any departmental action and /or disciplinary action as per law or statute of the University has been initiated by the University against Mr. Samit Pahari?
- 2) Whether any complaint has been lodged with the Police authority against Mr. Samit Pahari for the said malpractice? If 'yes' then please give details.
- 3) Whether Mr. Samit Pahari is still an employee of Jadavpur University? If 'yes' then please give details including his present post and salary.
- 4) Whether the Executive Council, the highest decision making body of the Jadavpur University has taken any action / decision on this matter? If 'yes', please give details.

On 17/02/2023 a reply was received from the Senior Director of Youth Welfare & PIO, Jadavpur University stating that *"In response to your application dated 10/01/2023 (received on 24/01/2023) under RTI Act, 2005 this is to inform you that your queries have already been sent to the concerned Section/Authority of the University for supply of information. No response has yet been received from their end"*

On 17/03/2023 an appeal was made before the Appellate Authority, i.e. The Registrar, Jadavpur University (Main Campus) with all the necessary documents but till date **"No Reply has been received against the said appeal."**

As from the prevailing circumstances it is clear that the PIO and the Appellate Authority of Jadavpur University has intentionally failed to discharge its obligations towards the provisions of the Right to Information Act, 2005 violating the provisions of the said act. Thus I am requesting your good office to provide me with the details hereby asked in accordance with the provisions of the Right to Information and also take necessary steps against the PIO and the Appellate Authority.

Your response within the stipulated period as per provision of the "Right to Information Act, 2005" will restrain the undersigned to take subsequent legal steps before the appropriate forum of Law.
