I have heard the appellant in length and perused all the material documents placed in file. Appellant Sri Amulya Ratan Mahato submits that he had filed five Misc. petitions dated 01.12.2020 before the Block Land & Land Reforms Officer, Hura. In respect of his Misc. petitions the appellant sought for three information before the respondent BL&LRO- 1) present position of the misc. petitions dated 01.12.2020 2) whether any step had been taken for hearing the said petitions & 3) And if no action had been taken then reason behind such inaction, who is responsible for such inaction and necessary time after which action will be taken.

The appellant also submits that even after the expiry of statutory time period to provide the information; no communication was received by him from the end of respondent BL&LRO.

Having heard the appellant I am of opinion that the BL&LRO should not sit idle after getting a petition under RTI Act, which is utter violation of the Act.

It is now directed to the BL&LRO, Hura to provide the precise position of the Misc. petitions of Sri Amulya Ratan Mahato, dated 01.12.2020 mentioning the stage at which the petition is lying, directly to the appellant within thirty days from the date of communication of this order.

It is also observed that in query no. 3 the appellant sought for reason if the answer of query no. 2 is no. But to provide any explanation does not fall within the purview of 'information' as defined in Sec. 2(f) of RTI Act, 2005. Hence even if the answer of query no. 2 is no, the BL&LRO will not provide any explanation under this Act.
