The photocopies of the applications are attached and collectively marked as Annexure: P5-P8.

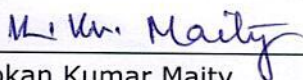
More than 120days have been passed since then, but there is no proper information has been shared by the above mentioned authorities cum State Public Information Officer and First Appellate Authority.

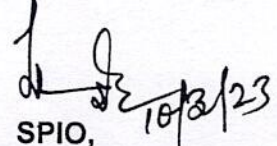

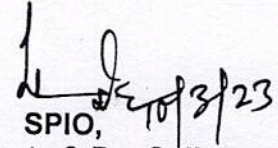
