More than 120days have been passed since then, but there is no proper information has been shared by the above mentioned authorities cum State Public Information Officer and First Appellate Authority.


Therefore, I am submitting this appeal under the Act, with the prayer to give directions to the appropriate authority to provide



I would like to inform you that I submitted a request for information under the RTI Act. to the SPIO of Office of The Sub-Division Officer (Egra) on 22.01.2023 and subsequently submitted the First Appeal application on 13.02.2023 after not getting the proper information from the SPIO.

On 22.03.2023, I received a reply from the Office of the BDO (Egra-II) cum SPIO where the information was also not provided clearly. My humble observations and humble submission are mentioned below in respect of the matter which is mentioned above.

Most Respectfully Sheweth :-

1. I requested the SPIO vide RTI Application vide letter dated 22.01.2023 to share the information about the list of documents (except bank details) which has been submitted by the applicants namely Sri. Bhabesh Chakraborty and Sri. Nripesh Chakraborty to get the sanction of the scheme under the PMAY-G.

Whatever the details received from the SPIO towards the RTI application dated 22.01.2023; those aren't actual information which is requested by me in above.

Whatever the details received from the SPIO towards the First Appeal application dated 13.02.2023; those aren't relevant to the actual information which is requested by me in above. After nominating the names in the SECC the above applicants may be submitted the list of the documents which must be required to get benefited under the PMAY-G scheme.

2. I requested the SPIO vide RTI Application vide letter dated 22.01.2023 to share the information about the list documents which are required to get benefited under this scheme of PMAY-G.

Whatever the details received from the SPIO towards the RTI application dated 22.01.2023; those aren't relevant to the actual information which is requested by me in above. The website link which was provided to me by the SPIO that's

the about page of the portal of Pradhan Mantri Awaas Yojana-Gramin (pmayg.nic.in) and the relevant details aren't mentioned in the said website page.

Whatever the details received from the SPIO towards the First Appeal application dated 13.02.2023; those aren't relevant to the actual information which is requested in above. The SPIO was mentioned in the replay that homeless or to living 0,1 and 2 Kutcha Wall and Kutcha roof houses with the name must be included in the SECC database. Also mentioned that if the name of the applicant was listed in PMAY-G; then Votar Card, Aadhaar Card, Bank Pass book photocopy and Land documents are required to get benefited under this scheme.

According to the above details it's clear that the proper information wasn't provided by the SPIO regarding the RTI Application;

as the information regarding the Q1 wasn't provided in pursuant to the Q2, and


The clear depiction of the information against the Q2 also not been provided as pursuance of the circular which was issued by the *Govt* and *GoWB* under the PMAY-G scheme. The SPIO mentioned that the land documents are required; but it hasn't clarified that the land should be in the name of the applicant or others, how much land needed, etc.

Therefore, I once again requesting and submitting this appeal under the Act, with the prayer to give directions to your good offices or the Public Information Officer to provide me the information at this earliest.


and it also being an indignity of the "Constitution of India" and "RTI Act, 2005".

With matter as referred to the above, the undersigned is providing the information below .

1. **Question :-** Please provide the relevant information (except bank details) that against the basis of which documents they got the sanction the scheme under the Pradhan Mantri Awaas Yojana- Gramin.

Answer :- The guidelines regarding selection of PMAY beneficiaries are as follows – “ To ensure the assistance, the target is to find those who are genuinely deprived and the selection is objective and verifiable. PMAY – G instead of selecting a beneficiary from among the BPL households, selects beneficiary using deprivation parameters in the Socio-Economic caste census (SECC) 2011 data which is to be verified by the Gram Sabha”.

The said two beneficiaries Sri Nripesh Chakraborty and Sri Bhabesh Chakraborty had been named in 2011 SECC Database (Annexure Page 1 & 2) and also Rural Household summary 2011 (Annexure Page 3 & 4)

Thereafter, the name of those two beneficiaries were fetched in permanent waiting list of PMAY -G with SI No.399 for Bhabesh Chakraborty and with SI.No. 48 for Nripesh Chakraborty after being found eligible by the Gram Panchayat. (Annexure – 5 & 6)

1. Ms Sancharini Ghosh (hereinafter referred to as the appellant) submitted two second appeals before the commission against two RTI applications as noted above filed to the SPIO, O/o the S.D.O. Egra, Purba Medinipur seeking some information.
A) a) Appeal no. 104683/2025 date of RTI 22.01.2023 seeking the following information;
i) Please provide the relevant information (except bank details) that against the basis of which documents they (i.e. Bhabesh Chakraborty and Nripesh Chakraborty) got the sanction the scheme under the Pradhan Mantri Awaas Yojana-Gramin.

- ii) Please confirm what documents are required to avail this Pradhan Mantri Awaas Yojana-Gramin
- b) The DM & DC, O/o the SDO, Egra, Purba Medinipur transferred that RTI application to the BDO Egra-II Dev. Block, Purba Medinipur with a request to provide the information directly to the appellant - vide memo. no. 45/G dated 30.01.2023.
- c) The SPIO, as per ATR memo no.345/E2B dated 11-02-2026, replied to the appellant vide memo no.712/E2B dated 10-05-2023.
- B) a) Appeal no. 603116/2024 date of RTI 10.08.2024 seeking the following information;
- i) Whether my application being dated 14.05.2024 which was received by the Block Development Officer, Egra-II after submitting the grievance at the website of WBPRD-PGRS and was sent to the G.P. Office for the enquiry and submission of a report after holding inquiry in r/o the matter enlightened therein? If so, the date of the sending of my grievance application to the GP may kindly be furnished.
- ii) Whether after holding necessary inquiry in respect of the matter contained in my aforesaid application being dated 14.05.2024 by the Pradhan of the Basudebpur Gram Panchayat Office any report of inquiry has since been furnished before the Block Development Officer, Egra (II)? If so, a copy of the said inquiry report so submitted by the GP may kindly be supplied to me taking further steps by me.
- iii) The prescribed list of the documents (copy enclosed Annexure-P1) has been mentioned in the eDistrict portal which has been maintained by the P & AR Department of GoWB to process the "Permission Letter for Delayed Birth Registration"; is it true? If so, the confirmation may kindly be supplied a report for taking the further steps by me.
- iv) Whether the application along with documents submitted at the eDistrict portal; then is there any requirement for hardcopy submission at your good office/offices? If so, kindly be supplied the report with mentioning the proper reason in such a manner.

- v) Whether the prescribed list of the documents (copy enclosed Annexure-P1) is true according to the knowledge of your good office/offices; then why the Block Development Officer, Egra(II) has been mentioned the rejection remarks on 29.07.2024 in the eDistrict portal as "Declaration of Feive person & Registered doctor certificate"? If so, requested to kindly be supplied declaration of report in such a manner for taking further necessary steps by me.
- vi) Whether the ID proofs is mandatory to submit along with the "Declaration form of Local Persons"; then why the same hasn't been mentioned in the eDistrict portal? If so, requested to supplied the information to me in such a manner for further necessary steps by me.
- vii) Whether the ID proofs is mandatory to submit along with the "Declaration Form of Local Persons"; then why the same hasn't been mentioned in the Declaration Form which is providing by the office of Block Development Officer? If so, requested to provide the information to me in such a manner.
- viii) Whether the verification is mandatory according to the departmental circular and rules then why the proper written communications hasn't been shared by the Block Development Officer, Egra(II); is there any specific reason? If so, kindly be supplied the information in a such manner for further necessary steps taken by me.
- ix) Whether the physical verification is mandatory; then why the Block Development Officer has asked me to be manually mentioned the all the Local persons contact number in the application? If so, kindly be supplied the information to me in such manner.
- x) Whether the contact number of the 4nos local person has been mentioned in the application; Have the Block Development Officer taken any kind of benefits through this contact details? If so, kindly be supplied the information in such manner for taking further necessary steps by me.
- xi) Whether the contact number of the 4nos local person has been mentioned in the application then why the Block Development Office not conducted the 1st stage of telephonic verification over the call? Is there any specific reason?

If so, kindly be supplied the information in such manner for taking further necessary steps by me.

- xii) There is a misguidance has been made by the dealing authorised personnel Shri. Ashis Gorai (Jr. Assistant) related to the verification process which has been communicated through over the call to delay the issue of the "Permission Letter"; the same also been communicated by me to the Block Development Officer and the SDO office; is it cross checked or any steps been taken by your good office/ offices? If so, kindly be supplied a report to me for taking the further necessary steps by me.
- xiii) A communication made through email by the BDO, Egra(II) (copy enclosed Annexed P15-P16) with addressed to the SDO, Egra related to my matter and also marked copy to the Basudebpur Gram Panchayat; but addressee as an SDO's email-id hasn't been marked in that email; is there any miscommunication are tried to create by the Block Development Officer, Egra(II)? If so, kindly provide me the information to take the further necessary steps by me.
- xiv) In the memo letter the BDO, Egra (II) (copy enclosed Annexed P15-P16) has been mentioned and enclosed an "Enquiry Report"; but the report hasn't been shared as an attachment with me; is there any specific reasons for hiding the such report by the Block Development Officer, Egra(II)? If so, kindly provide me the said enclosure report to take the further necessary steps by me.
- xv) A blank Letter Head has been signed & stamped by the Pradhan of Basudebpur Gram Panchayat on 06.08.2024 which is totally blank and the same has been taken by the Shri. Ashis Gorai (Jr. Assistant) of Block Development Office before leaving the GP Office, and it was seen by all the people who are present there; what does the paper belongs too? Is it official purposes? If so, kindly supplied the reason, and confirm where the paper has been used along with the proper details/ copy/ report.
- xvi) Is the same blank Letter Head of the GP has been used for the "Enquiry Report" and that's why the enclosure hasn't been shared by the Block


Development Officer through email? If so, kindly supplied me the report to me for taking the further necessary steps.

- xvii) The Block Development Officer, Egra(II) has been mentioned in his memo (copy enclosed Annexed P15- P16) that lack of supporting documents they are unable to process the application; it's unable to justify the which documents are required by the said BDO where the SDO, Egra already been communicated to conduct the proper enquiry as like verification process; then what is the additional documents needed by the Block Development Officer, Egra? If so, a copy of the report kindly be furnished where the list of the documents has been clearly mentioned and be supplied to me for taking further necessary steps by me.
- xviii) I have been surprised with the action of the Block Development Officer, Egra(II) related to the verification process; (i) The office said that they will go to the house of the local persons with my cooperation, (ii) Again the office said it's my duty to bring everyone at Panchayat Office; (iii) even it also communicated to me that I should bring everyone at Block Development Office, (iv) lastly the Memo shared by the Block Development Officer with mentioning the comments "non-cooperation of the applicant"; is it all the steps and actions being verified by your good office/ offices? If so, kindly be supplied the details of the cooperation which is required by your good office/ offices in such a manner.
- xix) According to the verification process the Government always be verified the details though their good office or under their subordinate offices; in my case the GP has issued the Form-10 and Succession Certificate which already been submitted at your good offices, and the GP also been under your good office/offices; then why the Block Development Officer not verified the documents through the officials of GP; also, if the GP isn't appropriate authority, then why the blank signed and stamped Letter Head has been collected from the GP Office? If so, requested to conduct an enquiry and be supplied the enquiry report to me for taking the further necessary steps by me.

- xx) Whenever a new project or the rule needs to be implemented between the Citizens that time the Government of West Bengal is passing the Circular or Order through his/her Secretaries and circulated with the implementation; in a such view the Health Department good office/offices for of GoWB or other competent Departments may have passed the Circular or Order related to "Permission Letter for Delayed Birth Registration"; If so, requested to be supplied the said Circular or Order.
- b) The SPIO & DM & DC, O/o the SDO Egra, Purba Medinipur received information from the SPIO & Jt. BDO Egra-II Dev Block, Purba Medinipur vide memo. no. 1827/E2B dated 19.09.2024 and that information had been provided to the appellant vide memo. no. 106/Con dated 23.09.2024
- c) The SPIO replied to the appellant vide memo no.17/Genl dated 12-02-2026.
2. Grounds for second appeal were non-response/dissatisfaction with the reply of SPIO and relief sought is to provide the information.

Decision and Deliberation

3. The appellant was absent despite the option of virtual hearing. She has neither sent any information nor any representative. She was not contactable on phone either. Both the SPIOs were present virtually.
4. It is seen that the appellant has filed two RTI applications dated 22-01-2023 vide para 1 (A) above and dated 10-8-2024 vide para 1 (B) (a) above. The first RTI application dated 22-01-2023 has been replied vide para 1 (A) (c) above. The second RTI application dated 10-8-2024 has been replied vide para 1 (B) (c) above. The Commission noted that the appellant has been replied adequately. The case is closed.
5. The matter is disposed of.
