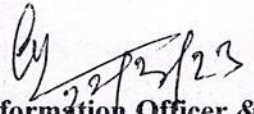

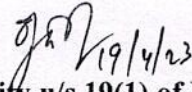

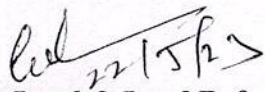

02 03/05/23	The appeal is taken up today for hearing as per schedule. Appellant Shri Samarendra Pal is present and filed haziran. Respondent SPIO & Deputy DL&LRO, Purulia is also present and filed haziran. Heard the parties at length and perused all the material documents placed before me. The appellant submits that he had applied under the provisions of RTI Act, 2005 on 16.03.2023 for obtaining some information before the SPIO & Deputy District Land & Land Reforms Officer, Purulia. In response to his petition the SPIO & Deputy District Land & Land Reforms Officer, Purulia sent a reply vide his office Memo No. V(RTI)-34/921/Cell/23, Dated 23.03.2023. He further submits that the respondent SPIO has not supplied point wise clear information with respect to his petition and being dissatisfied with the reply, the appellant preferred the instant appeal. Originally the petition was in vernaculars and the information sought for by the appellant written in Bengali language is translated and depicted below:

1. To whom and how to apply for Reconstruction of R.S. (Revisional Settlement) Records-of-Right? To provide Rules & Regulation and Circular of Government of West Bengal.
2. To provide information if there is any specific format for application.
3. If there is no format for application, whether application can be submitted in plain paper?
4. What are the fees of application? To provide Rules & Regulation and Circular of Government of West Bengal.
5. What are the fees for Reconstruction? To provide Rules & Regulation and Circular of Government of West Bengal.
6. How many days it will take to complete the Reconstruction of R.S. Records-of-Right after submission of the application? To provide Rules & Regulation and Circular of Government of West Bengal.

With respect to his petition, respondent SPIO & Deputy DL&LRO, Purulia replied,

"Apropos above-mentioned subject and reference point wise reply to the information sought for is furnished below:

1. Reply to query no. 1: Reconstruction of R.S. R-O-R is done as per Schedule C of West Bengal Estates Acquisition Rules, 1954 and subsequent amendments therein. As the said Rules is already in public domain, he is requested to go through the statutory document.

It is pertinent to mention here that there is no scope for any interpretation of the said Rules under the provisions of RTI Act, 2005.

2. Reply to query no. 2: Same as reply to query no. 1.
3. Reply to query no. 3: Same as reply to query no. 1.
4. Reply to query no. 4: Same as reply to query no. 1.
5. Reply to query no. 5: Same as reply to query no. 1.

6. Reply to query no. 6: Same as reply to query no. 1.

Respondent SPIO submits that the appellant has sought for information regarding Reconstruction of R.S. R-O-R which is done as per Schedule C of West Bengal Estates Acquisition Rules, 1954 and subsequent amendments therein. As the said Rules is already in public domain, no question arises to provide the same under RTI Act. There is no scope for any interpretation of the said Rules under the provisions of RTI Act, 2005.

It is evident from the reply that the respondent SPIO has already provided point wise precise information to the appellant. Hence, I cannot accede to such contention of the appellant that respondent SPIO has not supplied point wise clear information with respect to his petition. It is also evident that the said 'Schedule C of West Bengal Estates Acquisition Rules, 1954' which guides the reconstruction of R.S. R-O-R is already in public domain. Therefore SPIO is not required to furnish the same under the provisions of RTI Act.

It is pertinent to mention here that under the provisions of RTI Act the Public Information Officer is not required to furnish information which require drawing of inference and/or making of assumptions; or to interpret information; or to solve the problems raised by the applicants; or to furnish replies to hypothetical questions. It is also not required to provide 'advice' or 'opinion' to applicant which does not come under the purview of 'information' as defined under Section 2 (f) of RTI Act.

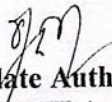
Therefore in my opinion the reply provided by the respondent SPIO & Deputy DL&LRO, Purulia does not go against the very spirit of the RTI Act. Thus I find no need to interfere with the reply provided by the SPIO & Deputy DL&LRO, Purulia.
