If additional amount was required for supplying information he/she should have intimated me through letter U/S 7 (3) of the RTI Act but the PIO failed to do so.

**First appeal against :** Deemed refusal of information U/S 7 (2) of the RTI Act 2005

The PIO did not respond me within 30 days of receiving my RTI application.

**Ground for second appeal :** Order of First appellate authority was not honoured by the SPIO.

The PIO was supposed to respond me under section 7 (1) of the RTI Act for supplying information but he failed to do so.

I appealed before the First appellate authority (or the FAA), for hearing my grievances but despite his order the SPIO has failed to give information till date.

The SPIO didn't reply within 30 days, then after waiting for a long time I appealed before appellate authority for his intervention, and despite the order of appellate authority to provide information immediately, the SPIO has failed to provide any information till date.

**Brief facts leading to appeal:**

The SPIO didn't reply within 30 days, then after waiting for more than 3 months I preferred an appeal despite the order of appellate authority, the SPIO has not moved and not provided any information to me, in this way I feel aggrieved and my fundamental right of
