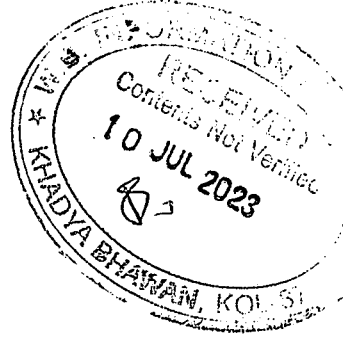

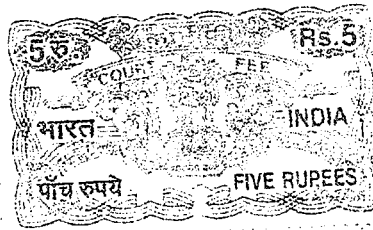
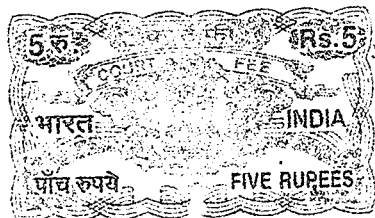

3. Please provide us with the attested photostat copies of all the Utilisation Certificates submitted by the school during the financial years 2014-15 to 2021-22, along with attested photo-copies of all the bills, cash memos, vouchers, etc. and other enclosures thereto, in respect of all the different grants received by this school and utilised during this period.
4. Please provide us with the attested photostat copies of all the Bank and postal Pass-books relating to all the accounts of this school containing all the entries for the financial years 2014-15 to 2021-22.
5. Please provide us with the attested photostat copies of all the bills, voucher, cash memos, all evidence of expenses made by the school during the period 2014-15 to 2021-22.

Please note that none of the documents as sought for by us hereinabove, is protected from disclosure under any section / provision of Right to Information Act, 2005 and providing the desired information would amount to transparency and fairness in public affairs, which is the objective of the RTI Act.
