

18.11.25 that the information has already been provided to the appellant vide memo no.

11670/RPT+RTI (R-127/2023) dated 28.07.23 and memo no. 16771/RPT+RTI+Enclo (R-

177/2023 dated 01.11.2023

Decision and Deliberations:

5. Sh. Sourav Roy is absent despite option to appear virtually. He has neither sent any

intimation nor he has sent any representative. His telephone number was tried but he is not

available. Sh. Ramkrishna Ghosh, the appellant and the SPIO both are present virtually.

6. It is seen that both the appellants have been replied vide para 4 above. It was also
