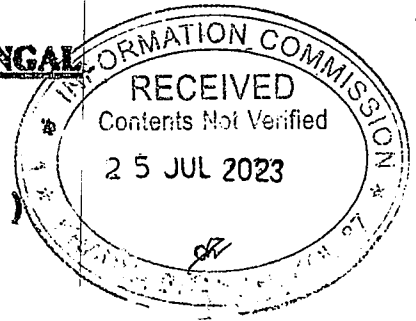

This is for your kind information that block number and flat number of most of the voters of Cossipore I.H.E are mentioned in the voter list of 40-Cossipore I.H.E. Tenants Welfare Association. Mentioning block number and flat number does not hamper our privacy issue. But most of the voters of A,B, C blocks and some other voters' flat number and block number are not mentioned in the said voter list.

Please explain why there is such a discrepancy in the said voter list.

Therefore, you are requested to include flat number and block number of every voter of the said housing estate in your voter list in public interest and to prevent corruption and kindly send the modified voter list to my email id.

Moreover, the information supplied in sl. no. -2 of letter memo no. KOL/EL0280 dated 28.06.2023 is not satisfactory. If you send part of the information to the concerned department and work collectively, it is possible to know the information of multiple voter id card of same person. Therefore, please send part of the information I want to know to the concerned department in public interest. If you do not provide information in this regard, I will submit application under RTI Act 2005 to the C.P.I.O. .

Tenants Welfare Association located at 87B Cossipore Road, Kolkata 700002 . Accordingly the Public Information Officer has supplied information vide memo number KOL / EL / 168 / 1001 dated 17.05.2023 but his supplied information is not satisfactory for the following reasons -

1. It is mentioned in the reply no. - 1 that " Certified copy of modified voter list (electoral roll) of the polling station 40 - Cossipore I.H.E Tenants Welfare Association can not be supplied as it contains third party information under private domain.

This is for your kind information that voter list is available on nvsp.in portal and anyone can download it from that portal. So it does not come under private domain rather it comes under public domain.

As per Section - 11 (1) , disclosure of third party information may be allowed if the public interest in disclosure outweighs in importance any possible harm or injury to the interests of such third party.

This mentioned voter list included some corruption or illegality. For your kind information Tatini Banerjee whose epic number is ARO1933456 showing that she is the resident of 87/B , BL-A, FL-21 but she is the daughter of Mrityunjay Banerjee whose epic number is ARO2737138 showing the residential address 87B BL G FL - 6L . This type of corruption or illegality in the mentioned voter list is aiding unlawful occupiers in our government premises. Therefore, it is the duty of the officials concerned to provide modified voter list in public interest.

2. Information supplied in reply no. 2 and 3 is not satisfactory. As per Section 6(3) of RTI Act 2005, in case, the requested information is held by another public authority/appellate authority, it is the responsibility of the Public Information Officer to transfer the application or part of it within five days. It must be remembered that both corruption and public interest are involved in this matter .
