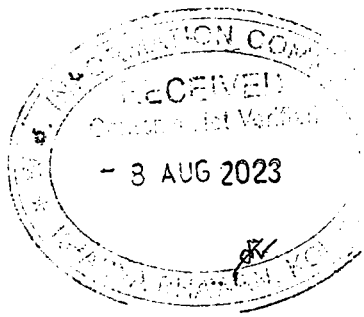

So, I request you to take necessary steps immediately to activate your department to provide me the information as sought for.

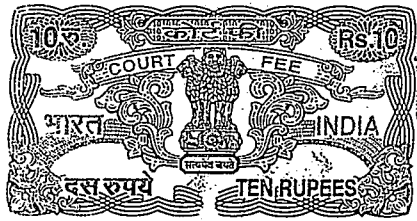
