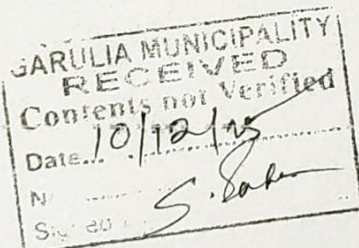
Sir,

In response to your memo no. quoted under reference above, this is to inform you that query nos. 1 to 3 of the RTI petition dated 28.03.2023 of Maqsd Hasan do not come under the purview of this office.

With respect to query nos. 4 & 5 of the said RTI petition, this is to state that, no entry in favour of any health centre under the jurisdiction of Garulia Municipality could be traced out in the existing Computerised Land Records held at the custody of the undersigned, resulting which information regarding nature of plot (recorded classification), plot no., exact name of the mouza, as desired, could not be retrieved from the records.
