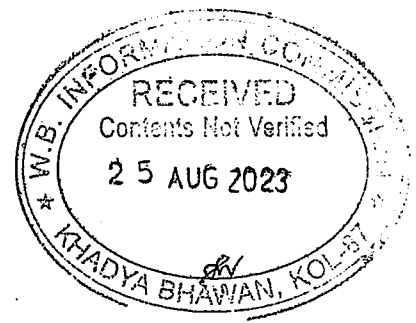

So I am filing the complaint against SPIO, MAKAUT, WB, as he do not give any proper reply against my RTIs & first appeals and also the second appeals.

All the RTIs were about the about available locational details of the following 2 colleges and a private coaching centre inside same premises:

A) Regent Education and Research Foundation (RERF) (Bara kanthalia, Barrackpore P.O.: Sewli Telini Para, Dist:- North 24 parganas Kolkata - 700121, a self-financed Engineering educational Institute in Barrackpore, Got Affiliation From All India council for technical education and Maulana Abul Kalam Azad University of Technology ,West Bengal)

B) Swami Vivekananda Institute of Modern Studies (Bara kanthalia, Barrackpore P.O.: Sewli Telini Para, Dist:- North 24 parganas Kolkata - 700121, a self-financed educational Institute in Barrackpore, Got Affiliation From Maulana Abul Kalam Azad University of Technology ,West Bengal)

C) I would like to inform you about a private coaching centre (CONDUCTING NON-TECHNICAL COURSES) inside the premises of Regent Education and Research Foundation. The details of the coaching centre are as follows (supportive document no 10):

From the CCTV footage of MAKAUT ongoing semester exam which was started from 02/06/2023 (which is monitored and recorded by Exam cell MAKAUT) it can be found that the **current semester exam of Swami Vivekananda Institute of Modern Studies had been held in Regent Education and Research Foundation Building** (exam in Room no 117, 118, 119, 120 and Library Reading Room was used as Exam Cell). It is the violation of the **affiliation terms and condition No 9, No 11, No 13 & No 17** given by MAKAUT, WB. Now I would like to know Whether the above-mentioned Two institutes got the special permission from MAKAUT or any Other relevant organisation to perform their daily academic activities as well as exam related activities in the same building?

2. What is the permission details / office order from MAKAUT or another relevant organisation to the above query no 1?

3. A private coaching centre **Career & Courses (CONDUCTING NON-TECHNICAL COURSES)** running inside the premises of Regent Education and Research Foundation, which is the violation of the **affiliation terms and condition No 8, No 11, No 13 & No 17** given by MAKAUT, WB. Now I would like to know Whether **Career & Courses** got the special permission from MAKAUT or any Other relevant organisation to perform their daily academic activities as well as exam related activities inside RERF building?

4. If the MAKAUT exam cell is not be able to contact an individual invigilator of Regent Education and Research Foundation (RERF) during ongoing semester examination, then I would like to know that is the following may be the probable cause?

Teachers is not be allowed to carry their mobile phone / carry the mobile phone in airplane mode / do not receive the phone call from MAKAUT Exam cell, under the strict instruction from local management and exam cell of the above-mentioned engineering college.

5. If it is seen during ongoing semester exam in RERF that some of the teachers are roaming without any duty or some of the students are moving suspiciously then is the following may be the probable cause?

Teachers are pressured to supply the answer of short questions, for which some of the teachers may roam in each room while they do not have any invigilation duty or some of the students may go to a particular room to collect the answer of short questions during examination.

6. What will the status of the affiliation if it is found that the above-mentioned both the institutes violates the rules and regulation of MAKAUT not only in the case of infrastructure but also do not obey the rules during semester exam?

7. Whether the above-mentioned organisations follow Prevention of Money Laundering Act, 2002?

As, I have not got any proper written answer from SPIO, MAKAUT, WB, So I am requesting you to intervene in this matter as on urgent basis and do the needful thus I can get the answer of above queries.

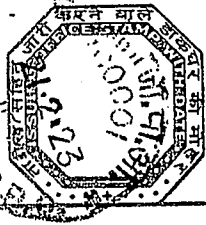
