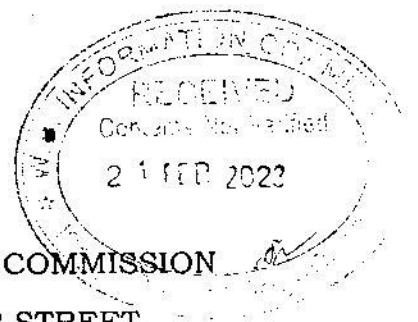

9. **Authority to whom the first appeal was made with address:** The 1st Appellate Authority, Office of the Secretary, The West Bengal Central School Service Commission, Acharya Sadan, Bidhannagar, Sector-II, EE-11 and 11/1, Kolkata, West Bengal, Pin Code - 700091.
10. **Decision of the 1st Appellate Authority, if any, including the number and date of the order:** No decision came from the 1st Appellate Authority and the said 1st Appellate application was refused by the 1st Appellate Authority via post dated 16.12.2022.
11. **Grounds for 2nd appeal and relief sought:** That The client of the present applicant made the application under RTI ACT, 2005 Dated 19.09.2022 *inter alia* regarding the marks obtained by him in TET 2005 and TET 2012 and the qualifying marks of the same. But no information was received by the client of the applicant. The applicant herein on behalf of his client on 14.12.2022 filed a First Appeal under Section 19(1) of the Right to Information Act, 2005. It is stated that the 1st Appellate Authority under Section 19(1) of RTI Act, 2005 refused to even receive the said 1st Appeal and audaciously returned the same vide post dated 16.12.2022. Thus till date no information was received by the application reasons best known to the authority concerned. The authorities till date did not supply the effective information to the applicant or his client.
12. The 2nd Appeal is well within the stipulated time prescribed under section 19(3) of the Right to information Act, 2005.


